Washington HC Quinn to serve as SU's 100th spring commencement speaker

SALISBURY — Washington Commanders Head Coach Dan Quinn '94, one of Salisbury University's most notable alumni will serve as this spring's commencement speaker, celebrating his alma mater's 100th graduating class.

In January, Quinn led the Commanders to its first National Football Conference championship game since 1991 — back when he was a junior at SU. He will now offer words of encouragement to SU's Class of 2025 during the undergraduate ceremony, slated for Thursday, May 22, at Sea Gull Stadium.

A prelude to the SU Centennial celebration, beginning in September, the event will mark the return of multiple traditions: Spring Commencement will be held on campus for the first time since the 1970s, and Quinn will serve as the University's first non-student Commencement speaker since 2001.

As a student, Quinn was a twosport athlete, excelling in track and

Habitat for Humanity of Wicomico County proposes two housing actions for council

SALISBURY — Habitat for Humanity of Wicomico County is drumming up support for two proposals that it says could help address a shortage of housing stock and affordability in the area.

President/CEO Molly Hilligoss estimates there is currently a shortage of 10,714 affordable units within the county. Before the 2008 housing market crash, she said there was an annual average of 800 homes built, with recent figures showing the num-

ber has dwindled to 150 homes built per year, pointing to a white paper published last year by the Greater Salisbury Housing Committee.

"When you do the math, part of the reason that we've got such a shortage of housing people can afford is because it just hasn't been built," Hilligoss said.

Hilligoss would like to have a work session with Wicomico County Council after sending a letter to county officials proposing two housing actions — a Wicomico County property tax credit for non-profit housing

agencies and a first-time homebuyer down payment and closing cost assistance for low-income homebuyers.

Tax credit for non-profit housing agencies

Habitat for Humanity of Wicomico County would like for the county to extend property tax credits for non-profit home builders such as Habitat and Salisbury Neighborhood Housing Services, Inc. for a period up to five years to offset the period from acquisition to the sale of the home.

field and football. He was inducted into the SU Athletics Hall of Fame in 2005. While at SU, he met Stacey, an athletic trainer. The two have been supporters of SU ever since, creating three endowments, benefitting football, track and field, and athletic training.

On the gridiron, he was a feared defensive lineman, recording 145

total tackles. A regular in the lineup during his final three years, Quinn played in all 28 games, with 135 tackles, two forced fumbles, a fumble recovery and one interception, which he returned for a touchdown. As a thrower on the track and field team, Quinn set the school record in the hammer throw (168' 8"), which stood for nearly 20 years, until 2012.

Quinn rose through the coaching ranks following his graduation from

SU, in assistant coaching roles with the San Francisco 49ers, Miami Dolphins and New York Jets. As a defensive coordinator with the Seattle Seahawks, he went to the Super Bowl twice, winning in 2014 as his defense put on an incredible show against Peyton Manning and the Denver Broncos in a 43-8 victory.

After a six-year stint as head coach of the Atlanta Falcons, including another Super Bowl appearance in 2017, Quinn spent the three seasons leading the Dallas Cowboys' defense, one of the best in the NFL in that time, before getting the call to head to Northwest Stadium.

Off the field, Quinn has received some of the league's most prestigious honors, including the Associated Press NFL Assistant Coach of the Year award in 2021.

Admission to the commencement is by ticket only.

"From the time we acquire a property to then selling it, we're writing grants. We're raising money," Hilligoss said. "It's not like we have buckets of money ready to rehab it."

The tax credit would end when the home gets transferred from the non-profit agency to a homebuyer, who earns under 120 percent of the area median income.

First-time homebuyer down payment and closing cost assistance

The local Habitat suggests creating a down payment and closing cost assistance program that would provide up to \$40,000 for first-time homebuyers who also earn under 120 percent of the area median income.

The homeowner would be required to own the property and occupy it for five years. The down payment/closing cost assistance would be provided in the form of a silent second mortgage and lien against the property for five years, after which the grant is forgiven.

If the homeowner sells or deeds the property to someone else within five years, the lien would be payable in full to Wicomico County.

The program would be on a first-come, first-serve basis, with income qualifying determinations verified by the county's planning and zoning director.

According to a United Way AL-ICE report, 38 percent of households in Wicomico County are cost-burdened, which means they spend more than 30 percent of their income on housing. Hilligoss said Wicomico County has 40,577 households, so that equates to 15,419 households.

Hilligoss said Wicomico County also has a 10.6 percent vacancy rate, with roughly 4,705 vacant units, but most of them are not habitable and beyond the point of rehabbing.

"A lot of these vacant homes really just need to be torn down and start over," said Hilligoss.

Hilligoss said the down payment assistance program would not have to be just for properties that Habitat or other non-profit housing agencies owns.

"Anyone that's a first-time home buyer buying a house that's earns under the 120 percent area median income would be eligible, including if they are building a house on family land like let's say in a rural area," said Hilligoss, pointing out that a lot of counties across Maryland have similar programs in place, including Montgomery County. "Maybe their grandparents gave them the land or whatnot and so they after they get their construction loan and they're closing out the construction loan for permanent financing, at that point the down payment assistance could come in."

Hilligoss, who has led the local Habitat organization for ten years, said they have felt the crunch of the local housing issues, with a first-time home buyer waiting list of roughly 29 families and 175 families waiting to sign up for its critical home repair program.

"We're on track to sell five homes for this fiscal year that goes from July 1 to June 30th," Hilligoss said. "And then we'll probably serve anywhere somewhere between 30 and 40 families with critical home repair programs. And that's a record."

But with any government program it comes down to funding and Wicomico County is no different.

"Funding the property tax credit is easy because that's just waiving a little property tax while we are developing a property short term," Hilligoss said. "It's not like the Horizon (program), it is very short term."

Wicomico County Executive Julie Giordano said Hilligoss has been working "diligently" with the planning and zoning department, trying to figure out exactly what the county can do to assist, even a potential use of cannabis funds.

For the down payment/closing cost assistance, Hilligoss has sug-

gested using the Community Reinvestment and Repair Fund, which is funded by a percentage of cannabis revenue. The funding is for local jurisdictions to support community-based initiatives that benefit low-income communities "disproportionately" impacted the enforcement of cannabis prohibition to support community-based initiatives.

Hilligoss said the cannabis money can only be used for programs and projects located in Tier's four and five of Wicomico County's map.

"It's supposed to be helping those parts of the county that are high poverty and so, what a perfect opportunity to get real dollars back and to get homeowners back into these high poverty areas," Hilligoss said. "Because when people own their home, they take pride in the landscaping and how the house looks.

They take an active part in their neighborhood. The kids do better in school because they're stable and not moving every six months. Home ownership is a game changer for a lot of families.

To Maryland lawmakers: Stop your legislative attempts to make Maryland less competitive

The Salisbury Area Chamber of Commerce, representing more than 700 businesses across the eastern shore, has grave concerns regarding legislation (HB 1554/SB 1045) that would expand Maryland's sales and use tax to business-to-business (B2B) services.

This proposed legislation will tax transactions between businesses for services including accounting, land-scaping, payroll and technology. If passed, it will create serious economic challenges for Maryland businesses, most of whom are small businesses. This legislation is a direct assault on

Maryland's small businesses.

HB 1554 and SB 1045 would isolate Maryland from its neighboring states. While this new tax may provide a short-term revenue boost, the long-term implications could outweigh the immediate benefits. Mandating that Maryland businesses absorb this new tax on essential services they rely on adds significant financial pressure on business owners. Moreover, if this legislation is passed and signed by the Governor, it raises concerns about the possibility of additional taxes on businesses in the future.

The Salisbury Area Chamber of Commerce will continue to collaborate with lawmakers in the General Assembly on initiatives that aim to grow Maryland's economy by promoting a competitive business environment. Unfortunately, this proposed legislation does not support those goals.



Maryland permanently preserves 4 additional working farms



ANNAPOLIS - In a continued effort to protect Maryland's agricultural heritage, the Maryland Board of Public Works recently approved four new easements through the Maryland Agricultural Preservation Foundation adding approximately 516 acres of preserved prime farmland across Somerset, Washington, Kent and Wicomico counties.

Of the 516 acres, an additional 154 acres were preserved in Wicomico.

"Preserving our farmland is crucial for Maryland's future," said Maryland Department of Agriculture Secretary Kevin Atticks. "Farmers who choose to protect their land are ensuring that future generations can continue to enjoy the agricultural resources we value so much. This investment not only boosts our local economy but also enhances food security and promotes sustainability in our communities."

Established in 1977 as part of the Maryland Department of Agriculture, the Maryland Agricultural Preservation Foundation works to purchase agricultural preservation easements from willing farmers. This commitment helps to protect prime farmland and woodland indefinitely. The newly approved easements will help maintain the state's agricultural landscape, support local food production, and sustain rural livelihoods.



To Maryland Lawmakers: Stop Your Legislative **Attempts to Make Maryland Less Competitive!**

The Salisbury Area Chamber of Commerce, representing more than 700 businesses across the eastern shore, has grave concerns regarding legislation (HB 1554/SB 1045) that would expand Maryland's sales and use tax to business-to-business (B2B) services.

This proposed legislation will tax transactions between businesses for services including accounting, landscaping, payroll and technology. If passed, it will

Maryland businesses, most of whom are small businesses. This legislation is a direct assault on Maryland's small businesses.

HB 1554 and SB 1045 would isolate Maryland from its neighboring states. While this new tax may provide a short-term revenue boost, the long-term implications could outweigh the immediate benefits. Mandating that Maryland businesses

create serious economic challenges for absorb this new tax on essential services they rely on adds significant financial pressure on business owners. Moreover, if this legislation is passed and signed by the Governor, it raises concerns about the possibility of additional taxes on businesses in the future.

that aim to grow Maryland's economy by promoting a competitive business environment. Unfortunately, this proposed legislation does not support those goals.

2025 Maryland General Assembly week eight update

ANNAPOLIS — The Senate Education, Energy, and Environment Committee and the House Economic Matters Committee held a Feb. 28 joint hearing on three energy bills sponsored by Democratic leadership in the Maryland General Assembly.

The first bill heard, Senate Bill 937/ House Bill 1035, the Next Generation Energy Act, broadly establishes that it is the policy of the State to encourage the development of nuclear power; requires the Maryland Energy Administration to pursue regional nuclear cost-sharing agreements with neighboring states and agreements with federal agencies regarding the siting of small modular reactors; establishes a procurement process for a minimum of 3,100 megawatts of dispatchable energy generation capacity and a related temporary Certificate of Public Convenience and Necessity (CPCN) process; and establishes the Maryland General Assembly's support of the extension or renewal of the federal license for the Calvert Cliffs Nuclear Power Plant in Calvert County.

Senate Bill 931/House Bill 1036, the Renewable Energy Certainty Act, as drafted would prohibit local jurisdictions from restricting solar energy projects and require expedited site development approvals. In essence, this bill undermines the ability of county governments to act in the best interest of their local communities regarding the regulation of renewable energy.

The Maryland Association of Counties, including all three counties in District 38 – Somerset, Worcester, and Wicomico, opposes the bill as drafted and provided opposition tes-

Written testimony from the Somerset County Commissioners noted the Somerset County Planning Commission and Department of Technical and Community Services has performed extensive research and conducted numerous meetings over the past 5 years for the siting and regulation of renewable energy in Somerset County, including a solar acreage limit of 1,800 acres, of which approximately 1,300 acres are already utilized by solar energy facilities.

"Under SB 931, Somerset County's input would have been severely weakened in siting these solar projects. Limiting the voice and involvement of our local elected officials and residents is unacceptable," said Senator Mary Beth Carozza (District 38). "Local governments, not the State, know best what projects would work in their home communities, and are in the best position to find the balance of bringing on new energy projects and protecting farmland in their own counties."

SB 931 in its current form also is opposed by the Maryland Municipal League, the Maryland Farm Bureau, the Delmarva Chicken Association, the Maryland Grain Producers Association, Eastern Shore Land Conservancy and Eastern Shore Heritage.

The third Senate/House leadership energy bill, Senate Bill 909/ House Bill 1037, establishes an independent Integrated Resource Planning Office in the Public Service Commission. "While I agree that we should develop a State comprehensive energy forecast, I am not convinced that we need a separate office that would create more bureaucracy and cost more money as Maryland faces a budget crisis along with the State's energy crisis," said Senator Carozza.

In addition to the Democrat leadership energy bills, the Joint Republican Caucus this week also presented

two bills to address the energy crisis to the Senate Education, Energy, and Environment Committee on February 27.

Senate Bill 479 would exempt public safety, emergency, and public utility buildings from Building Energy Performance Standards passed in the Climate Solutions Now Act of 2022. Senator Carozza is a cosponsor of SB 479, and Delegate Wayne Hartman is the House sponsor.

Worcester County Commissioner Chip Bertino testified in strong support of SB 479. "With Worcester County's vulnerable position as a coastal county, prone to hurricanes and flooding, we must consider the impact of Best Energy Performance Standards on public safety buildings and emergency shelters. While the majority of the large buildings in the county will still be required to meet energy performance standards, the bill would create an exemption for buildings like our government center, which houses the Sheriff's Office and the Emergency Operations Center."

Senate Bill 779, cosponsored by Senator Carozza, would put a pause on all the various elements within the Climate Solutions Now Act until that element became "economically practicable." Worcester County Commissioner Chip Bertino also testified in strong support of SB 779.

Senator Carozza questioned Commissioner Bertino during the hearing on SB 779, "In your testimony, you specifically tie your support to a practical way to balance environmental goals with the need to ensure local jurisdictions can provide essential public safety services. Can you expand on the public safety aspect?"

"From our position as a small rural

county, we need to ensure our emergency services are operating fully. To put all our eggs in one energy basket would place a tremendous strain on our system and would create an unpredictable and unreliable service that would be provided to our residents," said Commissioner Bertino. "We recognize that we need to balance our energy needs, and in this particular narrow instance we believe emergency operations should be exempt to ensure we can provide the services our people rely on."

Senator Carozza turned to Yuripzy Morgan, an attorney and frequent WBAL Radio host, when questioning began on SB 779. "You have a unique ability to take very complex issues and crystalize them. Taking the different issues, the business climate, the expectations of our constituents, what we are trying to do here today, how would you as an attorney and member of the media summarize where we are and the next step forward?"

"I would characterize where we

are now as death by a thousand cuts. The people that come into my office are ordinary people who have ordinary jobs who are just trying to raise a family and they are feeling the pinch from everywhere. The taxes, the regulations, the fees, the property tax assessment, the school issues that are going on, and then they are hearing about the proposed taxes that are coming, and especially energy," said Morgan. "Folks everywhere opened their electric bills in January and were absolutely astounded. And when I talk to these folks about these issues, they are even more stunned that we didn't see this coming. Marylanders have started connecting the dots, they say how could our legislators not have taken into account the direct impact

it would have on the ratepayers."

The Climate Solutions Now Act of 2022 has been cited as one of the main drivers of higher energy costs across Maryland and is estimated to cost taxpayers \$1 billion per year for implementation unless adjustments are made. The Senate Republican Caucus offered sixteen amendments on the Senate Floor to address ratepayer concerns, but only two amendments moved forward. The final vote for the Climate Solutions Now Act was along party lines, with all 32 Democrats voting for and all 15 Republicans voting against Senate Bill 528.

In addition to the Republican Caucus bills, Senator Carozza is sponsoring Senate Bill 675, which would require the Public Service Commission to analyze the full costs and benefits of sources of electricity in the State of Maryland. "We as policymakers must put our constituents first, and that means understanding how the development of various energy sources could impact the ratepayers," said Carozza. "This bipartisan bill is a commonsense approach to ensure the full costs and benefits in developing energy are calculated and policy recommendations should be based on the lowest cost and greatest benefit to the ratepayers." The hearing for SB 675 is schedule for Thursday, March

Carozza Local Bill Hearings

Senator Carozza testified in strong support of two Somerset County bills, Senate Bill 717 and Senate Bill 718. SB 717 would provide updated salaries for local officials to stay competitive with surrounding counties. SB 718 is a simple bookkeeping matter to legalize the actions that Somerset County had taken since the last printing of the Somerset County Code of Public Laws in 2016. Senator Carozza sponsored both SB 717 and SB 718 at the request of the Somerset County Commissioners.

Additionally, Senator Carozza testified in strong support of SB 680, which updates the Continuing Education requirements for real estate licensees to reflect current best practices in the industry. This legislation would remove provisions that have outlived their usefulness and any contradictions that cause confusion among licensees as to their continuing education requirements.

CAROZZA BILL MOVING THROUGH THE SENATE

Senate Bill 719, which would ensure long-term, stable funding for a reliably emergency services system that meets the needs of Somerset County, passed the Senate on Thursday (43-2). "It is imperative that we enable our local governments to increase resources to support our firefighters and EMS personnel now and into the future," said Carozza.

Earlier this year, the Princess Anne Volunteer Fire Company announced that it will not offer ambulance services to the community beginning July 1, 2025. The Somerset County Commissioners secured an extension of the services provided by the Princess Anne Volunteer Company until December 31, 2025, and is actively working on implementing a new Emergency Medical Services (EMS) plan for all residents.

Senator Carozza introduced Dr. Kalilah Camacho-Ali, A.K.A. Mama Ali, as her guest on the Senate Floor on February 26. Mama Ali, former wife of "The Greatest" Muhammad Ali, has visited well over 100 countries in her lifetime and met with over 50 Heads of State, as well as visiting schools across Maryland to discuss important topics such as bullying prevention.

"I am honored to be joined here today by Mama Ali, who has dedicated her life to faith, etiquette, kindness, and respect. I have seen her in action delivering her anti-bullying message at schools in my district,' said Carozza. "I am also honored to introduce her bodyguard, Adriano "Bubba" Almony, who now serves as the U.S. Chairman for Bodyguards Against Bullying. Bubba grew up in Ocean City and is a fellow alumni of my alma matter Stephen Decatur High School." "Bubba" Almony is a recipient of

a Presidential Lifetime Achievement Award and member of the Martial Arts Hall of Fame. He has organized multiple community events on the Lower Shore, including an annual toy drive in Salisbury during the Christmas holiday.

SENATE JUDICIAL PRO-**CEEDINGS** COMMITTEE KILLS CONDOMS IN SCHOOLS **BILL**

On February 28, the Senate Judicial Proceedings Committee voted down House Bill 380, which would have allowed condoms to be sold in vending machines in nursery schools, preschools, and elementary schools.

"I have heard from many parents across my district in strong opposition to this bill, and I join with my constituents in thanking the members of the Senate JPR for stopping this harmful legislation," said Carozza.




