### Easter egg hunt brings joy to Salisbury Boys & Girls Club members

SALISBURY — Nearly 60 Boys & Girls Club members were able to experience an early Easter thanks to a donation and partnership by Walmart store #2931 in Fruitland.

Excitement filled the air at the recently expanded Truitt Street Community Center April 17 as local children were given blue Walmart-logoed canvas bags and given the opportunity to go on an Easter adventure, searching for hundreds of treat-filled eggs strategically placed by store management, associates and staff of Maroon PR, a Columbia-based creative communications agency.

“One thing that Walmart loves to do is community outreach and fund in creative ways other than saying here’s a big check,” Maroon PR Account Manager Mike Twiname said.

Walmart Store Manager Shannon Argy said they are honored to give out community grants and events like the Easter egg hunt brings her “joy” to see the excitement of the children.

### Wicomico County Executive Giordano, staff and leaders reflect on past year

SALISBURY — Public safety, capital improvements and education were among many topics discussed during the April 10 State of the County Address held in Salisbury.

Wicomico County Executive Julie Giordano gave her third address since being elected in 2022 – the first woman to ever hold the post in Wicomico County’s history. Department heads and county leaders also provided feedback during the nearly two-hour event.

“Once again, I have invited them

to be part of this year’s State of the County address because we stand together as a united front, working collaboratively to serve the people of Wicomico County,” Giordano said.

Giordano said they introduced “six pillars of success” last year to help guide the vision and strategic initiatives for the county centered around employee recruitment and retention, public safety, modernization and efficiency of local government, education, economic development and community investment.

“These six pillars are not just guiding principles, they are embedded in

the very foundation of our budget, policies and daily decision making,” Giordano said. “Every initiative we undertake is measured against these priorities to ensure that we continue moving forward in a way that benefits our residents, businesses and future generations.”

#### Employee recruitment and retention

Giordano said she considers employee recruitment and retention one of the most important initiatives in building a strong and successful

She said it makes her “happy getting to work for a company that takes care of our community.”

“We do as much as we can, by volunteering at the homeless shelter or food pantry,” Argy said. “We try to look for organizations that are local to our store that we can take care of.”

Local Boys & Girls Club Manager Enaka Beteck said the April 17 event was the first but hopefully not the last time they are able to partner with the national retailer.

“Maroon PR reached out to me, asking would I be interested in having Walmart doing something with the club because Walmart has done stuff for our other clubs, so with us having this new club, it just makes sense for the local store to want to be part of this,” Beteck said. “It just shows that they care. It shows that they are all about the youth as well and they want to do their part in the community.”

Shortly after 2 p.m., a roll-up door opened, and the club members ran over to the large open field beside the center, in search of four golden eggs, that if found, would win them Easter baskets filled with treats from Walmart.

Seven-year-old Aniyah and ten-year-old Geneya both said they “were happy and excited” and “had fun” filling their Walmart bags. By 2:30 p.m., seven-year-old Ivory was not able to find one of the golden

eggs, but had a successful adventure, with most of her bag full.

“It’s great,” she said. “I love it because I love Easter, and we can have eggs and candy.”

The Easter egg event comes after an October 14, 2024 ribbon cutting ceremony attended by club leaders, local and state officials and members of the public celebrating the opening of the remodeled Salisbury club and its 3,900-square-foot addition.

Boys & Girls Clubs of Metropolitan Baltimore provides after-school and summer programming out of the Truitt Community Center.

Beteck said since moving in, they are seeing a rise in club membership, having more kids coming in from different areas of Salisbury.

“We are starting to see a rise in our members from the west side of Salisbury,” Beteck said. “Before it was mainly just the north and the east side of the city.”

He said with the expanded club, they can offer additional programming for the children, because it is easier to separate them by age. Their prior building was just one big space.

Additionally, Beteck said they are putting the passenger van that was donated by Bridgestone officials last October to good use.

“It means a lot of us,” Beteck said. “A lot of parents want to send their children to us, but they don’t have the means of transportation. With the van, it helps a lot. We definitely want the kids to come to the club.”

county government.

“From the very beginning of this administration, we recognized a significant concern among our workforce,” Giordano said. “Many employees felt unrecognized and unheard. And at times, completely overlooked.

“Some even expressed frustration over the lack of appreciation for their hard work and dedication to our county.”

Wicomico County Human Resources Director Donna O’Hara said her department serves more than 1,400 full-time, part-time and seasonal employees along with 360 retirees and hundreds of applicants. O’Hara said they have made “significant” progress on the retention front, with added wellness and financial benefits and ongoing training.

She said employee turnover decreased in twenty-one departments in 2024. Six departments saw reductions of more than 10 percent and four (departments) achieved drops of more than 50 percent in turnover.

“As a result, the county’s overall turnover rate dropped to just 7.58 percent, the lowest in five years,” O’Hara said. “To put that in perspective, in 2023 the turnover rate was nearly double that at 15 percent, and prior years it followed around the same trend, between 12 and 16 percent.”

### Public safety

Giordano said public safety remains one of the “most pressing concerns,” not just for Wicomico County citizens, but across the state and the country.

“A safe community is a thriving community, one where families can enjoy their neighborhoods without fear, where businesses can grow and where individuals feel protected,”

Giordano said. “However, achieving and maintaining public safety means ensuring that we can recruit, retain and support.”

Wicomico County Sheriff Mike Lewis highlighted the new public safety complex on Westwood Drive, saying they are already hosting training classes for deputies and leadership with certified instructors coming in from across the country. He also spoke of recent work with allied agencies, including the City of Salisbury, where they are working to get illegal ATVs and dirt bikes off the streets.

“We’ve been getting dirty, we’ve been crawling under cars, been crawling under trailers,” Lewis said. “We’ve been searching vehicles, we’ve been discovering false compartments and hidden contraband, and we’re teaching the latest and greatest techniques to go after not just drug traffickers, but all criminals here in Wicomico County.”

### Modernization and efficiency of local government

Giordano said over the past year, they have made “substantial progress” in modernizing government operations, streamlining services and making them more accessible to citizens. She introduced the recent implementation of a comprehensive strategic plan for the county.

“This plan marks a significant step forward in how we approach our county’s future, providing clear direction and a structured framework to guide decision making, allocate resources effectively and prioritize the initiative that matters most to our community,” Giordano said.

She said the plan not only outlines the county’s long-term vision, but also helps ensure that every department, project and investment is aligned with the county’s broader goals. The plan is available for public review on the county’s website.

“This transparency allows for greater engagement and feedback,

making it a true reflection of the community’s needs and aspirations,” Giordano said.

### Education

Giordano, a former educator, said that education is the “cornerstone of a thriving community,” and a commitment that extends from early childhood through adulthood.

“We believe that investing in education at every stage of life is critical to the long-term success and the well-being of our county,” Giordano said.

She announced that the proposed county budget, which was sent to the Wicomico County Council April 15, includes the full ask of the Wicomico County Board of Education, without breaking the revenue cap. Giordano also said the budget fully meets the funding request of Wor-Wic Community College.

“By supporting both our K-12 system and our local community college, we are making a comprehensive investment in education that benefits every generation in our community,” Giordano said.

### Economic development

Giordano said economic development is the “engine that drives prosperity, stability and opportunity” in Wicomico County.

“It is not just about attracting new businesses,” Giordano said. “It is about creating an environment where local enterprises can grow, where entrepreneurs are supported and where residents have access to good-paying jobs.”

Airport Director Tony Rudy said improving the infrastructure and expanding services at the airport continues to be a key focus.

Although there were delays with land acquisition and the corresponding environmental permitting for the future 1,200-foot runway extension, Rudy construction is expected to begin in June.

Rudy said construction is slated

to begin by the end of the year on a cell phone tower that will benefit employees and residents who live nearby. Construction on a solar farm is also expected to start this month that will provide \$600,000 in savings in energy costs for the airport and \$8.5 million in energy costs for the county in the future.

“We continue to explore new options to expand our air service at the airport and keep our passengers flying locally out of our airport,” Rudy said.

### Community investment

Giordano said community investment in Wicomico County involves building a stronger future together by enhancing the well-being and quality of life for all residents.

“Whether it’s improving infrastructure, supporting public amenities, or enhancing recreational spaces, we are dedicated to making meaningful investments that benefit every corner of our community,” Giordano said.

Giordano said they have prioritized paving and the repair of county roads, ensuring that the county’s transportation network is “safe, efficient and capable of supporting the growth” that the region is experiencing.

Other investments brought up included upgrades at the Wicomico Youth & Civic Center and the Arthur W. Perdue Stadium, public park and marina renovations and the addition of an off-leash dog park at Leonard’s Mill Pond Park.

“It is clear that the continued success of our county depends on the collective strengths of every department, entity and the dedicated individuals who serve within them,” Giordano said. “Each department or entity is a spoke on a wheel, unique in its purpose, but essentially keeping the county moving forward.”

"The NFL Inspire Change Initiative creates opportunities that empower and uplift children in our communities. This partnership rein-

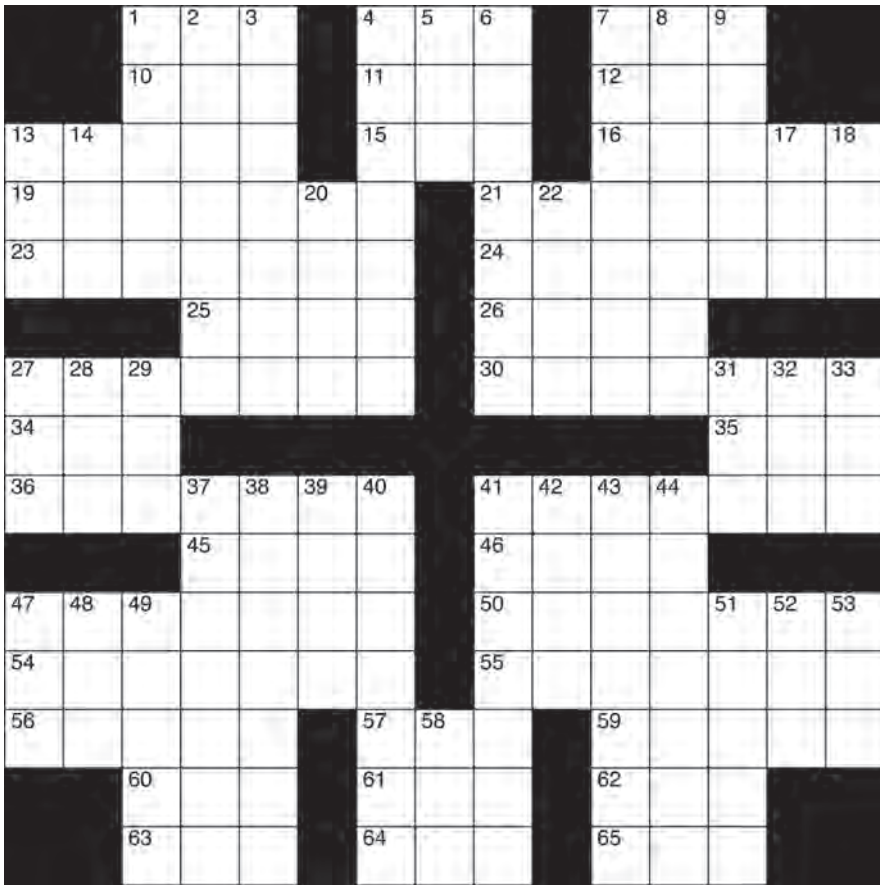

# SU's Lepre, Weer named among Maryland's Top 100 Women

SALISBURY, MD---Two Salisbury University leaders have been named among Maryland's Top 100 Women for 2025 by The Daily Record and BridgeTower Media.

The Baltimore-based newspaper featured SU President Carolyn Ringer Lepre and Dr. Christy Weer, dean of SU's Franklin P. Perdue School of Business, on this year's list, highlighting high-achieving women in Maryland who are making an impact through their leadership, community service and mentoring. This is the second Top 100 honor for each of them.

"I am honored to be named among Maryland's Top 100 Women for the second time," said Lepre. "Receiving this accolade is incredibly meaningful, but what means the most to me is being included on a list with so many incredible women, including Dr. Weer. Together, we are working to strengthen Maryland's educational institutions, healthcare facilities, businesses, government operations and much more."

"It is a privilege to again be named one of Maryland's Top 100 Women," said Weer. "I am proud to serve our students and community and even more excited about the growth I have witnessed in the Perdue School over the past decade-plus. I can't wait to see what the future holds for the Perdue School and for SU."

## Dr. Carolyn Ringer Lepre

Since becoming SU's 10th president in 2022, Lepre has enhanced the Eastern Shore campus in many ways. Under her leadership, SU has established a formalized graduate school; added new academic programs in high-impact areas, including a B.S. in engineering physics and M.A. in

public communication; and signed partnership agreements with agencies including NASA and the Maryland Army National Guard to enhance learning and career opportunities for students.

She also has worked to expand the University's study abroad opportunities, including new SU Global Campus programs in Scotland and Spain. Other new initiatives have included partnering with the Association of College and University Educators to improve student access through inclusive teaching practices; establishing a First Gen Sea Gull Scholars Program to enhance the recruitment, retention and graduation of first-generation students and help them thrive on campus; and a program to enhance understanding and implementation of strategies to assist students in successfully transitioning off academic probation.

Emphasizing diversity and inclusion as a priority, Lepre expanded SU's President's Cabinet to include SU's inaugural vice president of inclusion, access and belonging. She also centralized funds to provide ASL

interpreters at more campus events. Building on SU's legacy of environmental excellence, she prioritized funds to create a student-driven campus thrift shop, diverting usable items that otherwise may have gone to landfills; and procured a state investment that will help turn the campus' 1957 former library building into one of the University System of Maryland's first net-zero buildings as a student service center.

Lepre's influence also has extended to SU Athletics, where she hired the University's first female director of athletics and campus recreation, and reinstated golf (both men's and women's) as a varsity sport for the first time since the 1980s. Likewise, she hired the University's first marching band director in more than 40 years, with the expectation of reinstating that program in time for the start of the SU Centennial Celebration in fall 2025.

This has all been done through the framework of the "Salisbury Seven," a seven-point blueprint for SU's future success established by the President in 2023 with a focus on investing

in people; commitment to inclusion, equity and belonging; serving the needs of the state and local communities; high-impact practices; resources; and identity and reputation building.

In addition to her Top 100 Women honor, Lepre also has been named to The Daily Record's Higher Education Power List and its list of Maryland's Most Admired CEOs.

Weer earned her M.B.A. from SU in 1996. After working several years in the insurance industry and receiving her Ph.D. from Drexel University, she returned to SU as an assistant professor of management in 2009. She served three years as associate dean, starting in 2011, before becoming interim dean in 2014 and moving into her current position in 2015.

Under Weer's leadership, the Perdue School's programs have grown exponentially, positioning it as a regional leader in business education.

The Perdue School's entrepreneurship programs have grown tremendously in the last decade. In 2023, the Philip E. and Carole R. Ratcliffe Foundation renewed its sponsorship of SU's annual Ratcliffe Foundation Shore Hatchery competition for entrepreneurs in the Mid-Atlantic. Other sponsorships have grown the prize pool for SU's annual student Entrepreneurship Competitions and together, these initiatives allow the Perdue School to award up to \$300,000 in startup funding annually. In 2021, the Perdue School expanded its entrepreneurial offerings, opening the Rommel Center for Entrepreneurship at SU Downtown in downtown Salisbury.

During Weer's tenure as dean, the

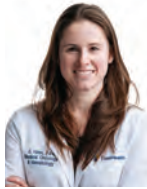

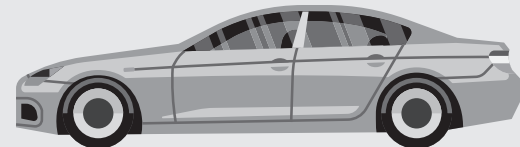
