# Salisbury Chamber celebrates The Twist Indian Grill grand opening

SALISBURY - For fusion cuisine fans, The Twist Indian Grill offers a feast of Indian specialties tastefully intertwined with Mexican staples.

The fast casual format eatery opened at 1315 S. Salisbury Blvd, Unit 2, across from Salisbury University on March 20.

On Wednesday, May 28 the Salisbury Area Chamber of Commerce gathered at The Twist for a celebratory grand opening ribbon cutting from 4 to 5 p.m.

Located across the street from Salisbury University, The Twist has been a homecoming of sorts for owner Priyank "Paul" Patel, who had been a student there 28 years ago.

"It's been a wonderful location," he said, drawing students and an array of other diners eager to experi-

# New time capsule placed at downtown Salisbury post office, but a mystery remains

SALISBURY — Salisbury Area Chamber of Commerce leaders in a hundred years hopefully won't be left to solve a similar mystery that current President and Chief Executive Officer Bill Chambers is faced with.

Chambers placed an 8" wide, 4" deep, 6" tall time capsule in the original cornerstone of the downtown post office May 29, months after hoping to find a similar box reportedly installed by his predecessors in the early 1920s. On a brisk December 18, 2024

morning, Chambers and others watched intently as a federally certified stone mason crew worked for nearly two hours, sawing and chipping away at the brick and mortar surrounding the ceremonial plaque.

But when the dust settled, only a few bricks were left, leaving an empty space, a minor mystery and lots of unanswered questions.

"I was shocked," Chambers said. "Every bit of information we had and the (Edward H) Nabb Research Center had was that it was put there in the 1920s. What we didn't realize was

the cavity was that small. We didn't know what to expect."

The Maude R. Toulson Federal Building, located at 129 E. Main Street, was listed on the National Register of Historic Places in 2016. It was the first federal building in Salisbury.

Chambers said the plan was to take the historical time capsule to a climate-controlled environment at the Nabb Center at Salisbury University until they did an opening event some-

# Wicomico County remembers fallen veterans during Memorial Day ceremony

SALISBURY — Hundreds returned to the Wicomico War Veterans' Memorial May 26 to hear the names of local veterans who died in the line of duty serving their country.

Members of the Wicomico County War Memorial Committee, which organizes the annual event held in front of the civic center in Salisbury, read aloud 191 names of armed forces members who never made it back home, while veterans, elected officials, and members of the community listened intently — some wiping away tears.

U.S. Army veteran and committee chairman Anthony Sarbanes noted the lack of an invited speaker, saying the ceremony centered around those who made the ultimate sacrifice to make sure Americans are free.

"The ceremony is reading those names," Sarbanes said. "That's the ceremony. ... We've been asked several times to have speakers and it's easy to find the answer. The answer is no. That's what it's all about."

The memorial was created after a group of veterans decided back in

2002 honor the memory of the county's fallen heroes. Flags from each service branch, along with a United States, Maryland, Wicomico County and the POW-MIA flag, fly over a brick wall displaying bronze plaques with the names of Wicomico County's fallen veterans beginning with World War I.

The ceremony included prayers for each branch of service, a lowering of the colors by the Wicomico County JROTC, ringing of the Red Knights Memorial Bell, POW/MIA Table remembrance and a volley of arms by the Wicomico County Sheriff's Office.

David Smith performed a rendition of Taps and Matthew Wallace sang Amazing Grace. Pastor Dean Defino gave the invocation and benediction.

"It's very important that we recognize veterans, past and present for their service to this great country," Sarbanes said.

time in 2025 to commemorate the 105th anniversary of the chamber. It was originally slated for the chamber's 100th anniversary in 2020, but the COVID-19 pandemic delayed those plans.

"COVID happened and then it took almost two years to get permission from the federal government to finally do what we did last December," Chambers said.

One explanation for why the time capsule is missing is that the building was expanded in the 1930s. A newspaper article during that period said the Maryland chapter of the Masons placed their own time capsule in what was the new cornerstone of the building. The original time capsule could have also been moved, but Chambers won't know for sure until the Masons take out their piece of history.

The register of The International Time Capsule Society estimates there are between 10,000 and 15,000 time capsules worldwide.

"It's just a rumor that it's behind the other plaque," Chambers said. "The Masons, I think their 100th year is coming up in six years. So, if they open that in six years, we'll see if ours is back there too."

But Chambers, being proactive, filled in the open space with a waterproof box containing items that he hopes will tell the story of the current chamber and its more than 700 members.

"We have a program from our annual awards, a program from the annual forecast event, photos of the board, business cards from the current employees, a lapel pin, a copy of this year's budget, an ink pin with the Salisbury Area Chamber of Commerce logo and some sponsorship information with different events," Chambers said. "We are trying to paint a picture of what we were doing in 2025 and who was here."

Chambers used his phone to take pictures of the May 29 reinstall of the ceremonial plaque from the 1920s and the new time capsule. He will send the documentation of the install to the chamber's files and to the Nabb Research Center, so there won't be any confusion a hundred years from

now of what is behind the brick wall.

"I think there is value in who and what came before us," Chambers said. "There is something to be learned about the formation of an organization a hundred years ago. I was curious to see what the forefathers of the chamber hoped it would become when they put whatever they put in the original capsule."

Chambers sat in the chamber's headquarters on May 29 reminiscing, shortly before carrying the box over to the former post office to be sealed until 2125.

"It's humbling to be a little tiny part of the chamber's history," Chambers said. "I was looking at the history of how Perdue and so many other partners started this 100 years ago and how we still going strong as an organization representing this business community. So yeah, it's neat. I just hope the chamber is still around 100 years from now."

"The first hour after the Dayton opening three years ago, Maulin called us in a panic, because there wasn't a single car in the parking lot," Paul Patel said. But after the second hour, business became nonstop. He soon opened another location in Milton, Delaware, then suggested to his sister and brother-in-law that they might

have success in Salisbury.

## CIVILITY CHECKLIST

 **Take the High Road.** Respond to the topic — not the person. Refrain from demonizing others for their opinions. Assume those you disagree with are, like you, genuinely interested in improving the community.

 **Be Respectful.** Bullying, public humiliation, insults, name-calling, harassment, and threats directed at another person — or that person's race, gender, religion, ethnicity, etc. — have no place in civil discussions. Find ways to respectfully disagree without questioning someone's character or motives.

 **Be truthful.** Base your opinions/arguments on facts. Value honesty. Make only accurate statements when making your point and avoid exaggeration and stereotypes. When appropriate, cite your sources of information that others may question.

 **Don't misrepresent.** Always identify your opinions as opinions (not stating opinions as facts). Never misrepresent the views of others or falsely claim your opinions represent someone else. If quoting the words of others, identify and credit the source.

 **Listen & Learn.** It's both polite and respectful to listen to those we disagree with (as well as those we support) and be genuine in our attempts to understand their point of view. Expand your mind by thoughtfully seeking out views that don't agree with your own.

 **Look for common ground.** When disagreeing with others, look for even small areas of agreement — which can be the gateway to working together for the greater good.

### Concern over proposed Medicaid cuts in new budget bill

The House of Representatives has passed and the Senate is considering drastic cuts to Medicaid, amongst other social programs. Wicomico County and the Lower Eastern Shore generally are not ready for the consequences should the cuts go into effect.

The U.S. House of Representatives passed a bill that would cut up to \$880 billion from Medicaid (insurance for the poor) over the next ten years, cuts that would be made by changing eligibility requirements and work requirements that would likely see 7-10 million people of the 74 million on Medicaid thrown off. In Wicomico County where I live, around 23,000 of my neighbors are enrolled in Medicaid, around 4,000 of whom could be cut by the new eligibility requirements.

What would the planned cuts to Medicaid mean to our community? It would mean that Medicaid recipients would face more out-of-pocket costs even as Congress considers cutting foot stamp benefits, clean energy credits, and subsidized heating and cooling costs. It would mean earlier death

for those who lose their insurance. It would mean lost revenue for major employers like TidalHealth, Chesapeake Healthcare, and others; statewide, up to \$1.5 billion could be cut from the GDP leading to 14,000 lost jobs and \$130 million in lost tax revenue. It would mean increasing costs for those of us with insurance as TidalHealth and others increase charges to pay for the newly-uninsured who are still guaranteed a right to necessary care.

The rationale for this chaos is checking unproven but apparently rampant welfare fraud and removing the "lazy" from a benefit, both of which are absurd. No proof of widespread Medicaid fraud has been shown, at least not Medicaid fraud by recipients; insurers and hospitals engage in Medicaid fraud all the time, and this would not stop that. Of those on Medicaid, 45% are children or retirees, and most adults work, with only 3% of total Medicaid recipients who are capable of working not doing so. This bill would not increase the number of Medicaid recipients who work, just take benefits

away from those who cannot prove they work. Oh, and illegal immigrants do not qualify for Medicaid.

Furthermore, the bill would extend temporary tax cuts (which largely benefited corporations and the wealthy) made in 2017 which would increase the federal deficit by up to \$4 trillion (not a typo) by 2034, a deficit increase that the Congressional Budget Office estimates would force up to \$500 billion in cuts to Medicare, which is insurance for the elderly. What form would those cuts take? That is unknown currently.

This is just part of the bill, and those curious about its other terms are encouraged to learn more, but the Medicaid cuts alone make this a catastrophic law that would impose cruelty in life and harshness in death upon those unlucky enough to need Medicaid (or even Medicare).

### Maryland is drowning. My son, and your grandchildren, deserve better

My son just turned one. As I watch him take his first steps and say his first words, I worry about the drowning world we're handing to him. Here in Maryland, the consequences of climate change are no longer abstract. They're visible in every tide line and storm surge, in every flooded road and acre of salt-ruined farmland.

In Talbot and Dorchester counties, roads now flood on sunny days. Saltwater is creeping into fields that once grew soybeans and corn, ruining farmland that's been in families for generations. We are watching our land slip away—not decades from now, but today.

That's why I was furious to see Governor Moore veto the RENEW Act—a bill that would have measured the cost of climate change to Marylanders and begun holding fossil fuel giants

financially responsible for the damage they knowingly caused. It was a first step toward making polluters, not local families, pay for Maryland's recovery and resilience.

Governor Moore called it "burdensome." But burdensome for whom? The polluters who won't pay a dime, while local governments and taxpayers like us are left scrambling to fund shoreline reinforcement, flood repairs, and emergency response? Why are we paying for their profits with our wallets, our safety, and our kids' futures? I understand Governor Moore's concerns for our state's financial situation, but this bill would be the first step toward generating, quite literally, billions of dollars from fossil fuel giants for Maryland's recovery and resilience. How is that "burdensome?"

We know what's happening. We've seen the tide rise and the storms worsen. And our children will inherit whatever we don't fix. Tackling climate change can feel overwhelming, but we have real solutions—the RENEW Act was one of them. Our voices matter, and together, we must demand that our elected officials put those solutions to work and override this veto. We deserve leaders who work for people, not polluters, and who won't make Maryland taxpayers pay for a crisis they didn't create.

My son deserves a livable climate. Your grandchildren do, too.



SALISBURY — Judges in the 24th round of Salisbury University's Philip E. and Carole R. Ratcliffe Foundation Shore Hatchery entrepreneurship competition were inspired by a son's dedication to improving the quality of life for his mother, awarding magnetic wireless electrode kinesiology tape company Lectra Technologies, Inc. with this semester's top funding amount: \$35,000.

Founder Jake Henry, of Camp Hill, PA, was able to help his mother run pain free after a long battle with debilitating osteoarthritis with his wearable device and app that not only treats musculoskeletal pain without the need for medications or surgery, but also outlasts competitors.

Held at Junior Achievement of the Eastern Shore's Perdue Henson Center, the competition featured 15 applicants from throughout the Mid-Atlantic vying for their share of \$100,000 in prize money. Other winners included:

- Krave, LLC – Aliyah Newman, Rachel Ransom and Angel Hobbs: The beverage company aims to combat the Washington, D.C., bar scene's high prices and inconsistent options. The ready-to-drink canned cocktail bridges the gap between premium mixology experiences and affordability - \$25,000

- Consult Lemonade – Tierra and Wali Lathan, Jasmine Mack and Kelvin Jones: This management and technology resource firm in Columbia, MD, specializes in the development and employment of underrepresented talent that leverages innovation and technology - \$15,000

- Blackwater Apothecary – Nicole Bishop: This Salisbury-based metaphysical supply store aims to en-

hance current offerings and expand in the wholesale market - \$10,000

- Easy Oat Burgers – Desiree Calixte: This easy-to-make; gluten friendly; and dairy-, MSG-, GMO- and soy-free, plant-based, at-home burger mix is packaged in Frederick, MD - \$5,000

- GaiaXus – Dietrich Ruehlmann: The GaiaXus Water Guardian, based in Germantown, MD, is a water quality monitoring system designed for citizen scientists, students and educators - \$5,000

- Sustainabli – Kevin Tu: This Baltimore company promotes energy efficiency in research, education and health care settings with innovative sensor technology - \$5,000

In addition to funding, winners and participants also receive mentoring support from the program's board. Mentors include business leaders such as Chris Perdue of Perdue Farms, Inc.; Mike Cottingham of the Rommel Companies; Dr. Erinn Tucker-Oluwole of the University of Maryland Eastern Shore; and Matt

Cohen of SIMPLi.

This round's winners join the program's 128 previous award recipients, who have self-reported estimated profits of some \$35 million annually, creating 1,169 jobs to date.

"The goal of this program is to assist where we can make the most lasting impact," said Michael Jensen, SU executive director of entrepreneurship, "We want to play a role in expanding business growth and increasing job creation in our communities."

Following the competition, the Ratcliffe Foundation announced another \$900,000 gift to continue the Shore Hatchery program through 2029.

The program was established with an initial \$1 million contribution in 2013. In 2017, the Ratcliffe Foundation announced a second \$1 million gift to continue the Shore Hatchery through this spring, followed by the 2022 announcement of an additional \$900,000 to maintain the program through 2026.

Administered by the Perdue

School and the Dave and Patsy Rommel Center for Entrepreneurship, its goal is to fund and provide guidance to entrepreneurs with active small businesses in order to achieve greater scale and market reach.

"This program offers an important stepping stone for startups," said Jensen. "The award removes specific obstacles to growth and enables expansion."

Up to \$200,000 annually is available for those applying for grants through the Shore Hatchery program. Its board of directors selects recipients based on presentations. All competitors have the opportunity to meet with SU's team at the Rommel Center for Entrepreneurship to discuss resources available to support their businesses.



# Online application for Senior Farmers Market Nutrition Program now open

Salisbury Independent

ANNAPOLIS — The Maryland Department of Agriculture's state-wide online application for the Senior Farmers Market Nutrition Program is now open. The application can be found on the department's main website and will be open until all benefits have been distributed.

Low-income (185 percent of the federal poverty level), older adults age 60 and older are encouraged to apply. Depending on which local jurisdiction in which they reside, recipients will either be sent their card directly in the mail, or will be required to pick up their card at a designated location, coordinated by the local Area Agency on Aging. Eligible applicants who seek additional support with the on-

line application may reach out to their local Area Agency on Aging.

The Senior Farmers Market Nutrition Program offers a one-time, annual benefit of \$50 that recipients can use between July and November to purchase fresh fruits, vegetables, herbs and honey directly from farmers at farmers markets and farm stands across the state. Recipients will receive a card with an embedded QR code that they can use to pay for these items with participating farmers at their local farmers market or farm stand (see example of the card on the left).

Additionally, many farmers markets also participate in the Maryland Market Money program. Participants using federal nutrition benefits can expand their purchasing power

at participating markets by receiving matching funds from Maryland Market Money. When attending a participating market, locate the Information Booth to find out the process for how the different nutrition benefits are matched at that market. Currently, more than 100 farmers markets across Maryland have at least one farmer who is authorized to accept Farmers Market Nutrition Programs, with a total of 160 farmers who accept the benefit.
