



charge. Items such as paint, motor oil, gasoline, fluorescent bulbs, wax, car and appliance batteries, pesticides, obsolete electronics such as monitors, modems, desk phones, and stereos, and automobile and light truck tires will be accepted. Items that will not be accepted include microwave ovens, large appliances, yard debris, household garbage, construction debris and commercial materials. Ponte Vedra Utility System rate adjustment

Ponte Vedra Beach renourishment back on radar

Commissioners vote 4-1 against adopting MSTU to fund feasibility study

Following the wake of another hurricane season, the conversation about Ponte Vedra Beach restoration is back on the agenda.

This time the question involves equity. The St. Johns County Board of County Commissioners considered FY 2020 Tentative Millage Rates and Budget during a public hearing Sept. 12. The board brought up the question of leveraging money for the

Ponte Vedra Beach renourishment feasibility study rather than implementing the Municipal Service Taxing Unit for fiscal year 2020. While the MSTU was established in order to tax residences located within North Ponte Vedra's renourishment zone, current beach renourishment projects for Vilano, South Ponte Vedra and St. Augustine did not require such a tax.

In a motion prompted by Commissioner Blocker, the board decided against adopting the 0.6 millage assigned to the MSTU for FY 2020, which would have gone into effect Oct. 1. The motion was approved 4-1, with District 1 Commissioner James Johns dissenting.

Roscoe community marina to be revisited

In rare decision, board votes 5-0 to reconsider proposal

The proposed Roscoe marina was brought to the board's attention again at a Sept. 17 public hearing, even though the community marina zoning variance was overturned in August. Proponents of the marina suggested revisiting the issue, even though the issue did not appear on the agenda. In an unusual turn of events, the board voted in favor to

readdress the project, 5-0.

The marina's developer, Paul Rohan, alleged both misrepresentation of facts and extortion from the opposition during public comment.

"The four appellants that filed for an appeal (did so in) a plan to extort money and leverage their position into getting whatever they wanted," Rohan said.

What can you share about your background?

I was born in New York and grew up in upstate New York.

What was your experience with minor league baseball?

I played one year in Penn league and one year in Independent league. I loved the long bus rides and the comradery. I was not as good as I thought I was. I was a pitcher and my neck is still sore from watching balls fly over my head as batters were beating my best pitches all over the place!

What led to your interest in wine?

Wine needs to be sold and taught to restaurants and retailers to be able to be enjoyed by consumers. It is very important to educate the buyers and staff, share information and stories — it makes a difference to show

how wines differ and really take the time to educate your consumers.

Tell us about your current role with Rombauer Vineyards.

I am the Rombauer Vineyards sales manager for the Southeast USA region. I work with our distributor partners and customers education and selling Rombauer's portfolio of wines. I do a lot of market work, out on the streets working hand-in-hand with each of our distributors. I also spend a lot of time supporting local wine events in the area as well as hosting many wine dinners in restaurants and festivals in my region. I enjoy educating my customers on the Rombauer story and sharing our delicious wines!

Do you prefer red or white?

I like it all — no preference on red or white but I do drink depending on my food pairing or my mood.

For someone new to wine, what's a good way to get started?

You just have to get out there and taste. Try new and different wines — old and new world — and try all

varietals. You will be surprised at how much is out there! And take the time to educate yourself on the wines you try; do a little investigative work. If you decide to make it a career, look to work at a wine shop or restaurant then get some experience working in a distributor learning wine and how to sell it.

What do you enjoy most about living in Ponte Vedra?

This is a great place to live. There is so much to do—beaches, golf, boating, fishing. This is a very good and growing market. I believe it is the best place I have ever lived. Prior to coming here, I lived in New York, North Carolina and several South Florida locations—Ponte Vedra is the best!

I enjoy golf and love to go to great eateries and, of course, drink great wine!

Would you like to tell us about your family?

I have a daughter who got married last year and moved from Houston to Denver. The rest of my family are my great friends and fantastic colleagues.



2019 Sing Out Loud Festival continues through Sunday

The Sing Out Loud Festival makes a cultural impact on Northeast Florida, attracting hundreds of artists to about a dozen St. Augustine venues to entertain residents and visitors alike. Most of the performances are free, but the Saturday, Sept. 21 benefit concert at The Amp was sold out months in advance.

Ponte Vedra High School students start Investor's Club

Club aims to teach financial literacy to college-bound students

For most, the words "teenager" and "financially savvy" don't go hand-in-hand. Many remember a procession of fiscal fumbles that followed them well into their 20s before mismanagement evolved into a semblance of financial literacy. Trial and error, also known as "learning the hard way," is pretty much taken for granted as the harrowing steps toward adulthood. Seventeen-year-old Ponte Vedra High School students, Jack Landis and Tyler Leinan, decided, however, that rather than pay for the knowledge out of pocket, they were going to grab the bull market by the horns.

Born from the ashes of negative bank account balances was The Investor's Club.

"Overall, we see the Investor's Club as striking a unique market that conventional education is lacking — financial preparedness," President of the Investors Club, Jack Landis, said.

The club hosts guest speakers and runs stock market simulators to help teach students the ins and outs of investing in a complicated economic system.

"We do some career-oriented stuff as well," said Vice President Tyler Leinan.
"We have people (in the industry) come in and talk about their careers. They explain how if someone wanted to pursue a career in finance, how to go about that."

Landis said that the idea came to him as a simple "supply and demand" deficit that students weren't being provided. So much so, his first meeting hosted over 50 students in attendance.

"Many say 'I didn't even know this was



a thing you could do," said Landis. "Or, 'I didn't even know this was a thing you had to do."

The two organize every meeting, setting up guest speakers and coordinating the stock market simulator, which they use competitively between members to win "Best Top Earner." Recently, the club hosted a financial advisor previously employed at the Empire State Building and Merrill Lynch's Senior Financial Advisor. From both they learned the importance of safe investments as opposed to risky ones, as well as the steps it takes to get certified as a certified financial planner.

Currently, both presidents are interested in expanding their club's reach to other schools in the district. They hope that by setting up satellite Investor's Clubs, they can not only expand the knowledge of financial literacy but have schools to compete against for Best Top Earning club in the stock market simulator.

Rohan indicated he had both email and voicemail evidence, which he submitted to the board. Additionally, the developer said the canal's hazards were fabricated, citing evidence that there were no police reports pertaining to a life-threatening watercraft incident that opponents of the marina specified at the previous meeting.

"We pulled the police reports, and nobody was crippled." Rohan said. "Nobody was sent by helicopter with a broken neck. Shame on these people for coming up here and lying to you.'

The proposed marina site is east of the Intracoastal Waterway and south of the Palm Valley Bridge, near the boat ramp. The project included 75 slips of unenclosed dry berthing storage, which

was suggested to create less of an environmental impact. Also incorporated were 12 wet slips to line the Intracoastal Waterway, although not intended for overnight use.

District 5 Commissioner Henry Dean suggested that although revisiting the zoning variance was unusual, he was compelled to do so.

"This is a rare action I think, to revote and reconsider an item," Dean said. "But based on that there are so many facts in dispute that were presented to us and I made a decision based in a large part on a number of those facts. Be them right or wrong, I would like to take the time and interest to hear again. It's a bit rare, but in our effort to seek the truth I am willing to sit here and spend a whole day if that's what it takes to hear both sides so we can make an informed, intelligent decision."

Marina

According to public works director, Neil Shinkre, the county has received a grant of matched funds from the state, leaving a remaining \$700,000 of funding needed for the intermediate phase of the North Ponte Vedra project.

"My concern is I think this is an equity issue," Blocker said. "We have other parts of the county, specifically South Vilano beach restoration effort. We did not require those residents to pay the initial feasibility studies, but we are requiring that for Ponte Vedra. Frankly, I would ask the administration and the board to look at this. I think the county needs to find a way to absorb that remaining \$700,000."

Public concern regarding Ponte Vedra's beaches has reached a tipping point, with many residents at the meeting asking the board why the project wasn't commenced sooner. For those living on the coast, the dune line has been pushed back 30 to 40 feet post hurricane Matthew, reaching what is considered a critical condition.

According to District 5 Commissioner, Henry Dean, the beach's issue wasn't on the board's radar until after the hurricane's damage severely eroded it.

"This county has worked hard for the past 12 years on St. Augustine Beach and for the last three years on South Ponte Vedra and Vilano Beach," Dean said. "We've done little or nothing for Ponte Vedra Beach. That's a fact... .I don't think we went out of our way as a commission over the last five or 15 years to ignore this problem. I don't think it was a serious problem until after Matthew and Irma. Then, it became a critical problem. We are trying to do something about it, and we are committed to that."



Beware of scammers impersonating FEMA workers

Florida Chief Financial Officer and State Fire Marshal Jimmy Patronis warned Floridians impacted by Hurricane Dorian about scammers impersonating Federal **Emergency Management Administration** personnel. Reports of these scammers were coming in from the Jacksonville area, but could be widespread.

"Storms bring out the best in people, but sometimes they can, unfortunately, bring out the worst in people," Patronis said. "My office is hearing of reports of people impersonating FEMA telling them not to evacuate. FEMA does not go door-to-door or call you to offer assistance. After the storm, legitimate companies will never ask for cash up front to make repairs. Always remember, if it sounds too good to be true, it probably is."

Patronis' office offered the following tips on how to spot storm scammers.

■ Verify: Verify the identity of individuals claiming to represent government and

relief agencies or insurance companies. Official personnel should display ID badges, should provide identification without

hesitation. If you suspect that someone is impersonating official personnel, contact the local police department or sheriff's

office immediately.

- Beware of door-to-door agents: Imposters often go door-to-door claiming to be FEMA representatives, asking for money to assist with the filing of federal flood claims. FEMA does not charge for this service and does not go door-to-door in this capacity.
- Beware of robocalls: Imposters claiming to represent FEMA typically call consumers and ask them to hang up and dial a 1-800 number to make an insurance payment ASAP to prevent policy cancel-
- Too good to be true: If an offer sounds too good to be true, it most likely is. Don't deal with anyone who demands cash up front. Don't sign anything.

Fast facts about flooding

Floods can be highly destructive natural disasters. The U.S. Geological Survey's Water Science School says that around 71 percent of the Earth's surface is covered by water. While oceans hold about 96.5 percent of all the planet's water, rivers, lakes, ice caps, and glaciers also are large water sources.

National Geographic points out that flooding has caused more death and destruction than any other kind of natural disaster in the United States. Flooding may result from overflowing streams or rivers; when coastal storms cause the sea to surge inland; if a dam or levee has ruptured; if ice melts rapidly in the mountains; or if excessive rain cannot be absorbed by the ground fast enough. Flooding can even occur without warning, and such instances are referred to as "flash flooding."

Staying safe during floods involves understanding floods. The following information, courtesy of the Emergency Management Institute, FEMA, Ready. gov, and National Geographic, can help men and women better understand floods and how to stay safe in flooding

- No region is safe from flooding. Floods can occur anywhere, but are rare in areas where water is scarce.
- Floods may develop very slowly or in just a matter of seconds after an extensive rainfall.
- Areal floods can occur where saturated grounds are present.
- Although the term "hundred-year flood" describes an extremely large and very rare event, these types of floods have recently been occurring worldwide with increased regularity.
- In the United States, floods cause about \$6 billion worth of damage and kill, on average, 140 people every year.
- Coastal flooding alone attributes to \$3 trillion in damage worldwide.

Prepping pets for an emergency

There are still three months left in hurricane season, and now that Hurricane Dorian has come and gone from Florida, it is time to revisit emergency plans and procedures. Regardless of how quiet the season has been so far, it is not over yet, and it is important to have a disaster preparedness plan in place to be ready for the next storm.

Residents may have emergency supply kits in place for themselves, but how prepared are family pets? Emergency pet kits are an important part of an overall emergency plan, and entails more than just packing a little extra food and water.

First, consider the kit itself. What should go into it? At least three days' worth of food for each pet is recommended, though in Northeast Florida, it may be advisable to keep more on hand. Along with water for human family members, be sure to keep extra on hand for pets. A day's supply of water for dogs less than 50 pounds is 1 ounce per pound. Larger dogs need a gallon of water each day. Since cats are generally smaller, their daily supply is only 0.5 ounce of water per pound.

Clean towels or bedding should be included in the emergency pet kit to clean up after or to handle nervous or scared pets. It is important to help keep the pet as calm and comfortable as possible.

Always keep current medical records and medications close at hand in an emergency. Pet-friendly shelters will only allow pets that are current on their vaccinations into the shelter.

In the chaos of an emergency, it can be easy to lose track of pets. Incorporating them into our disaster plan can help keep them safe during and after an emergency.

Extra litter and disposable litter boxes for cats are important as well, especially when staying at a shelter. Even cats that usually go outside should be kept in-

doors immediately after a storm or other emergency to prevent loss or injury. Having clean litter will be vital.

Having a separate first-aid kit for pets is recommended; though incorporating extra supplies in the family's primary first-aid kit will also work. The same types of items, such as cotton bandages, tape and antibiotic ointments used by people are also used on pets.

Besides an emergency pet kit, it is important to keep an updated list of friends, family, shelters and hotels that will allow pets, preferably outside the immediate evacuation area. Include phone numbers, addresses and driving directions in case GPS does not work. Keep a hard copy of the list in the emergency kit.

Unable to get to a pet in time? Make arrangements with a friend or neighbor who may be able to take care of any pets until it is safe to return to them.

KEEP PETS SAFE AND COMFORTABLE

Microchipping is important no matter what, but the likelihood of a pet becom-

ing lost greatly increases during and after an emergency. Make sure the information embedded in the microchip is up to date. Veterinarians, shelters and animal rescues can scan the pet's microchip and hopefully get them safely back home.

In the chaos of an emergency, it is easy to lose track of pets. Getting them comfortable being in a crate or carrier before disaster strikes will make it easier to keep them safe during and after an emergency. Practice getting them used to it now so he or she will go easily into their safe enclosure when the time comes.

Pets are an important part life for many of us. Keeping them safe during and after an emergency should be of primary concern. Creating an emergency pet kit and building protocols for pets into our disaster plans can help ensure a smoother transition and recovery for everyone.

- China's Yellow River valley has been home to some of the worst floods in history.
- Flood waters can quickly knock people off their feet and carry them away.
- It's important to sanitize oneself after coming in contact with flood water, which could be contaminated with vari-

ous natural and manmade substances.

- It may be necessary to move to higher ground when flooding situations occur. It's important to heed safety precautions and evacuation messages.
- Rapidly moving water has the potential to carry a house, car, trees or other structures away.
- Drivers should not try to navigate through flood waters. Many deaths that occur during floods happen when drivers try to move through flood waters.
- It's imperative to keep an emergency kit, nonperishable food, flashlights, and batteries on hand to combat potential disasters like floods.
- Flood damage is not necessarily covered by homeowners insurance. Those who live in high-risk flood zones would be wise to purchase flood insurance to protect themselves.

Floods can be formidable foes. Armed with information, people can be safer when the waters rise.

How to handle prolonged power outages

Accidents and storms can disrupt the electricity that powers everything in homes and businesses. A short-term loss of power can be a nuisance, but extended power outages can cause damage and may even be dangerous.

Widespread power outages are often anticipated during or after severe storms, which can disable entire power grids. Because damaged power lines and infrastructure must be carefully assessed after severe storms, it may take anywhere from hours to several days before power is fully restored.

The Food and Drug Administration says food spoilage is one of the hazards of long-term power outages. If a storm is imminent, you can be proactive by freezing the contents of the refrigerator when possible so that items can stay at safe temperatures longer, advises the FDA. Food can remain safe for up to two hours at refrigerator temperature before it starts to spoil. Grouping food together in the freezer also can help it stay colder longer. Having extra ice on hand or freezing containers of water also can provide a chilling effect, as well as serve as a water supply if faucet water is unavailable — which can be a concern for those with well-pumped

Your barbecue can turn out to be your best friend during power outages. Many stoves, even gas ones, will not light because of electric ignitions. A gas camping stove or barbecue can serve as the primary place to cook food until power is restored. Always have a secondary propane tank on hand.

Keep plenty of bottled water on hand, especially if your water supply is well-fed and requires an electric pump to activate flow

Stock up on blankets and warm clothing. Power outages during the winter can be especially challenging because of the lack of heat in a home. Family members can huddle together in small rooms to conserve heat. People with wood-burning stoves can use them to keep warm. Fireplaces tend to be more show than ambient heat providers, but they can still serve as a heat source in a pinch.

If you have a generator, run it safely. The Consumer Product Safety Commission says generators should be operated as far away from the house as possible to avoid deadly carbon monoxide fumes. Also, use appropriately-gauged, outdoorrated extension cords to power up generators.

It is also important to stay put and avoid the road after a storm that causes a power outage. Wires may be down, traffic lights may not work and dangerous debris may be littering the roads. Hunkering down is the best approach until power is restored.



Varsity Blues: Part II

Will Aunt Becky wind up in jail? If actress Felicity Huffman's sentencing in the Varsity Blues college admission scheme on Sept. 13 is an indication, it's likely. But the bigger question is: Do they deserve it

and how much is enough?

Prosecutors have charged 51 people in the Federal college admissions case, including coaches, a college counselor and his employees, and 34 parents whose children allegedly gained admissions to elite colleges based on fraudulent pretenses. Those schemes ranged from, in Lori Laughlin's case, faking evidence that her daughter was a stellar rowing team member, even though she had never participated in the sport, to knowingly hiring others to take standardized tests for their children. The latter was what Felicity Huffman pleaded to and for which she was sentenced to 14 days in jail, followed by probation to pay a \$30,000 fine and perform 250 hours in community service. To date, 15 of the 34 parents have pleaded guilty, and those who haven't can expect significantly more time than Huffman if








Paternity leave: I did it and you should, too

ebrated my first Father's Day and feel compelled to share the choice I made to take paternity leave.

On Aug. 20, my life changed forever. My wife, Lauren, gave birth to our twin boys, Valentino and Mas-

simo. Their birth was the best thing that has happened in our lives.

Before their arrival, we had to make many important decisions, including the hospital at which my wife was going to give birth, whether or not to vaccinate them, making sure we had enough diapers and wipes, and choosing the right shade of blue for the nursery.

As an attorney, I had another big decision to make: Should I take paternity leave after they were born?

Like all good lawyers trying to answer a question, I did my research. I reviewed the employee handbook of the firm I was with. I asked other fathers and read articles online.

My former firm had a parental leave policy, which was consistent with the Family and Medical Leave Act, but left pay during leave up to the discretion of the management committee. Other fathers I talked to took anywhere from one day to two weeks of leave after the birth of their

I gathered from speaking with fathers that taking paternity leave was frowned upon or regarded as something that men, especially lawyers, do not do.

That stance became so obvious during my discussions with some fathers that I began to feel guilty for considering taking paternity leave.

According to fatherly.com, 92 countries offer paternity leave, but the U.S. does not. Further, only a few states mandate paid parental leave: New York, California, New Jersey, New Hampshire and Washington, D.C., have laws in place requiring employers to provide paid leave to employees.

Therefore, it is no surprise that so many fathers shy away from taking meaningful paternity leave. Our culture does not

The 10 highest divorce rate states in the U.S.

entirely support it and you are not likely to get paid. After more research, I realized the right amount of paternity leave was a personal choice that is unique to each person's situation.

I needed to decide the amount of time that would allow me to start establishing a connection with my sons, help my wife and sons as much as I could, start learning how to be a father and to love them as much as I could without any distraction. I decided to take one month paid paternity leave.

When I delivered the news to my firm, I received full support. My colleagues, both attorneys and staff, covered all of my work while I was gone. I will always be grateful to them for allowing me to do this.

The day after my sons were born, I disabled my work email on my phone, put my computer away and embarked on an amazing, yet very difficult, nearly uninterrupted month of paternity leave. I focused on being a father and husband, while my colleagues managed my clients and workload. Just as I expected, when I returned, everything was in order and my "work world" was still revolving on its axis.

In fact, when I returned, my colleagues and clients were eager to hear about my newborns and see pictures. No one expressed any resentment that I took leave.

To all employers, I strongly urge you to support your expecting male attorneys to take a meaningful paternity leave. You can attract great employees and build loyalty to your firm.

As a partner at a law firm, I know the potential logistical issues this could cause for your office and the financial implications of paying someone who is not

However, with high turnover in the practice of law, employers should consider offering meaningful paternity leave as a way to attract and retain talented lawyers. High turnover is much more expensive for an employer than a reasonable amount of paternity leave for an employee.

My advice to future fathers is to try to take as much paternity time as possible without compromising your employment. If you cannot take all of your leave at once, consider breaking it up into two parts.

I know this is easier said than done, but for those who fear judgment or retribution from their employers and colleagues, ask yourself if that is the type of office you want to be associated with in your career.

I realize that my stance on paternity leave may not be widely accepted in the legal community. The purpose of sharing my story is to shed light on a topic that is taboo despite the fact that it is relevant to all families.

I want to encourage and empower new fathers to choose precious time with their newborn over billable hours and work. If you don't do it now, you could set yourself up to choose work over family more than you

they are convicted. But how much is enough?

As a criminal defense attorney, I would argue that 14 days in jail is just enough to disrupt and possibly ruin someone's life, but not enough to serve as a deterrent. I have certainly argued that a crime like Ms. Huffman's does not warrant jail, and that her contrition and lack of prior criminal record weigh in favor of a non-incarcerative sentence. But, prosecutors in the Varsity Blues made a persuasive argument for incarceration, mainly based on other comparable cases. The U.S. Attorney cited a case in which Atlanta teachers and school administrators were convicted in a conspiracy to cheat on standardized tests and they received as much as three years in prison; all of the defendants were African American. (NY Times, Sept. 13, 2019, "Felicity Huffman Sentenced to 14 Days Behind Bars"). The Government pointed to another case in Ohio, in which an African American mother was sentenced to five years in prison for using her father's address to enroll her children in a suburban school district.

Celebrity, race, wealth have all, historically, led to favorable treatment in the criminal justice system.

The judge, in pronouncing Huffman's sentence, seemed mindful of not appearing to favor her because of her position in society, when she said, "Trying to be a good mother doesn't excuse this. A person in a position of wealth and the position you are in is in a much easier position in this meritocracy. I do think this is the right sentence here... [It allows] you to move forward and you can rebuild your life after this. You pay your dues."

Judge Talwani added, however, that without a term of incarceration, Huffman would face a future of "the community asking you why you got away with this." But the question remains, what does the community make of a jail sentence of 14 days? And the issue, to this defense lawyer, isn't why doesn't Huffman get more? It's, why doesn't the mom in Ohio get less?

'Brighton Beach Memoirs' at Alhambra is a reminder of what really matters

Admittedly, I don't know very much about the inner workings of a 15-year-old boy's mind, so "Brighton Beach Memoirs," currently playing at Alhambra Theatre & Dining, offered some compelling — and hilarious — insight.

The semi-autobiographical play written by Neil Simon, focuses on Eugene Jerome, a precocious teen growing up during the 1930s, who longs to be a writer, and spends much of his time fantasizing about playing baseball for the New York Yankees — and about his 16-year-old cousin Nora.

Eugene (Evan Gray) lives in quaint home in Brighton Beach, New York, with his parents Kate (Hillary Hickam) and Jack (Robert Herrle), his 18-year-old brother Stanley (Cameron Hale Elliott), his Aunt Blanche (Stacey Harris) and her two daughters, Nora (Kelly Wolfe) and 13-year-old Laurie (Emma Decker), who suffers from heart "flutters." Eugene narrates much of the play from his perspective, including what he perceives as constant nagging and disapproval from his mother and his burgeoning interest in girls, especially his pretty cousin.

The real centerpiece of the story, however, isn't Eugene's experiences and thoughts, but the delicate balance of the family dynamic, such as juggling feelings of responsibility, financial turmoil,

past hurts and an unknown future with unconditional love and dedication to each other.

Eugene's dad Jack works himself almost to death to take care of the family financially, but still manages to offer helpful advice, compassion and words of wisdom, while mom Kate feels responsible for everything running smoothly in the home, even as she often feels overwhelmed and unappreciated.

The actors in Alhambra's performance did a spectacular job with their roles, from the spot-on New York accents to displaying the genuine emotion of a family enduring misfortune while maintaining love and devotion for one another. The costume and set design felt authentic and conveyed the proper time and place.

Gray, who plays, Eugene, is a perfect fit, looking and acting every bit the energetic, curious and whimsical 15-year-old

protagonist. Hickam also has a standout performance as the beleaguered Kate, whose obvious stress and worrying is balanced by her inner resolve and family devotion.

In between Eugene's generally humorous personal commentary, were some truly heartfelt and heartbreaking moments, including Kate's built-up resentment toward her widowed sister, Blanche's indecisiveness and loneliness, Stanley's fear and pain of disappointing his parents and Nora's feelings of abandonment after the death of her father.

By the end, I felt I did get to see into the mind of a 15-year-old boy (scary), but, more importantly, I felt like I got to be part of the Jeromes' resilient, wonderful family.
