Local family featured in ad during big game

St. Johns County potato farmer DeLee Parker, 5, and her family were featured in a commercial broadcast during the third quarter of the Super Bowl on Sunday, Feb. 9. The commercial, titled "The Little Farmer," was produced by Frito-Lay for its Lay's Potato Chips brand with the tagline "Lay's are made from real potatoes, and our potatoes come from real farmers."

St. Johns County Board of County Commissioners (BCC) Chair Krista Joseph recently visited with local farmers to discuss creating a new Agriculture Advisory Board for the BCC.

"For generations, our local farmers have grown agriculture in St. Johns County, and on Sunday, this heart-warming commercial will grow the world's attention to the responsible farming happening in our community," said Joseph.

According to the National Football League, last year's Super Bowl had more than 123 million viewers.

The 60-second commercial concludes with a photo of DeLee holding two potatoes from the family's Parker Produce in St. Johns County. That transitions into a photo collage of her dad, Jeffrey, his dad Jeff and his dad's cousin Scott, along with their multiple generations of farmers in the family

Signals to be installed at S.R. 207 intersection

At its Feb. 4 regular meeting, the St. Johns County Board of County Commissioners unanimously authorized the award of the construction contract for intersection improvements at State Road 207 and Brinkhoff Road. The improvements will include a new signal-controlled intersection with an ADA-accessible crosswalk. Additionally, the current asphalt will be milled, resurfaced and reconstructed with raised islands to prevent through-cut traffic from Brinkhoff Road and Twin Lakes.

Chinchor Electric Inc. will lead construction of the project at a cost of \$1.695 million. Construction is estimated to begin in the spring and be completed by the fall.

Birding course offered

Join this five-week course on birding, "If You Can Name It, You Can Love It," starting Saturday, Feb. 15, at Guana Tolomato Matanzas (GTM) National Estuarine Research Reserve. The course is 10 to 11:30 a.m. Feb. 15 and 22 and March 1, 8 and 15.

Learn about what makes the area supportive of many bird species and how to use birding applications to enhance your ability to identify birds and create a personal bird list. You will also practice your skills in the field.

Funding OK'd for Flagler Estates Fire Station, Sheriff's Office

At its Feb. 4 regular meeting, the St. Johns County Board of County Commissioners unanimously authorized the award of the

construction contract for the Flagler Estates Fire Station 21 and Sheriff's Office. The 6,036-square-foot joint facility for St. Johns County Fire Rescue and the St. Johns County Sheriff's Office will be located in the Flagler Estates community with easy access to the surrounding Hastings area.

Vargco LLC will lead construction of the project at a cost of \$4,001,674. Construction is estimated to be completed by the end of the year.

Ramp planned at Crescent Beachfront Park

A new ADA-accessible beach ramp and additional parking will be constructed at Crescent Beachfront Park, 6930 A1A South. The project's construction contract was approved by the St. Johns County Board of County Commissioners at its regular meeting on Feb. 4.

The ramp will be nearly 200 feet long and wheelchair accessible and will reduce foot traffic on the vehicular ramp, improving safety. The new parking area will add 28 additional spaces and refreshed landscaping, as well as a concrete sidewalk connector between the parking lot and the new beach access ramp.

A total \$700,000 is budgeted for the project's design and construction. Work is estimated to begin in the spring and be completed by the summer.

U.S. Attorney: Restaurant owner pleads guilty to immigration law violations

U.S. Attorney Roger B. Handberg has announced that Hua Yao Ke, 38, of Jacksonville has pleaded guilty to establishing a commercial enterprise for the purpose of evading a provision of the immigration laws. Ke faces a maximum penalty of five years in federal prison. A sentencing hearing has not yet been scheduled.

According to the plea agreement, Ke owned and operated the Kamiya 86 Sushi and Thai restaurant located in Ponte

Vedra Beach, where he employed workers who were unlawfully present in the United States. Contrary to federal law, Ke did not require the workers to provide documents to establish that they could legally work in the United States, according to a report from the U.S. Attorney's Office for the Middle District of Florida.

Ke also owned a residence at which he provided free housing to the undocumented workers, and he provided the work-

ers with free transportation between the house and the restaurant, the report said. He also paid the workers in cash and did not withhold taxes and other payments from the workers' wages, the report said.

This case was investigated by the U.S. Department of Homeland Security and the U.S. Border Patrol with assistance from the St. Johns County Sheriff's Office. It is being prosecuted by Assistant U.S. Attorney Arnold B. Corsmeier.

Tell me about your background as an artist.

I have been a working artist for a while now. I have a visual arts degree from Eckerd College in St. Petersburg since I'm originally from the Gulf Coast. As a child in the Gulf, I pretty much had free rein. I could wander the farm and go all over. I was always an observer, a looker, and I've just always been interested in the outdoors, the creatures and the environments. That's the inspiration for my work, and it goes back to those childhood wanderings.

How did you get into the medium of artmaking that you currently use?

When I was in school, I had an instructor who was a printmaker, so I ended up becoming really interested in printmaking. Printmaking can be very technical and process-oriented, and it can also

entail using some not-so-great chemicals, so a while back I started doing some exploring and I discovered a method of what's called collagraphs. It's the marriage of two words: collage and graph. In traditional printmaking, you use a metal plate, you etch into the metal and you transfer the image to paper using ink. With collagraphs, I essentially create a plate out of low-tech materials and I build up textures to score into the board, and then I transfer that image to paper using my artist press.

How long have you been working with the Butterfield Garage and how did you achieve Artist of the Month?

I've been a member at the Butterfield for probably about eight years, maybe a little longer. I'm a board member. It's become my hometown art community. Every month, people typically create new art for a chance to be Artist of the Month. The gallery supports its artists by

doing press releases and such, and then your opening is on the First Friday Art Walk. The reason that I was selected for Artist of the Month is because I received the Arts for All grant from the St. Johns Cultural Council. Part of my grant was to create this body of work called "Once Around the Sun," and that was what I showed at the Butterfield for Artists of the Month back in July.

Tell me more about your "Once Around the Sun" series.


I wanted to explore the idea of featuring local flora and fauna for each month of the year. There are 24 pieces and I'm revising a few, but the bulk of this series is completed. Each month has a large piece, an 18-by-24, and a smaller piece to go with it. For example, January has a piece that features robins. For February, I chose squirrels. Every month has a representative image inspired by the local, native flora and fauna.

Would you say this is your favorite series you've worked on?

Yes, definitely. I was not active for a couple of years recently, due to being a caretaker for my mom, and then I had a health concern of my own. So, returning from that, I really needed a boost, and doing this series has been a bridge for me. What I do is a little obscure, but I've enjoyed focusing on what I'm interested in and not getting distracted.

Looking ahead to 2025, do you have any goals that you're working towards?

I'm just revising some of the images from my series and just kind of gathering my thoughts on how I want to proceed forward with what I learned from it. I'm going to return to teaching a little bit, too. I have ideas for a workshop in my brain, but I don't have a formal commitment yet. I have lots of things percolating.

Leek files legislation addressing animal cruelty

State Sen. Tom Leek (R-Ormond Beach) recently filed legislation related to animal cruelty offences that further defines the term domestic animal and provides additional criminal punishment.

Senate Bill 502 states that if the offender is convicted of the primary offense and the primary offense is a crime of animal cruelty toward a domestic animal, the subtotal sentence points are multiplied by 1.25 under the Florida Criminal Punishment Code.

“Abuse against helpless animals is one of the most heinous acts that can be committed, and punishment for a perpetrator should be swift and severe,” said Leek. “I am proud to continue my work in addressing animal cruelty in the state of Florida by strengthening penalties for those who prey upon domestic animals.”

State Attorney R.J. Larizza of the 7th Judicial Circuit has expressed his full support, stating, “This bill will hold those accountable who choose to torture and abuse animals.”

Concurrent with that measure, Leek has also filed Senate Bill 494, which provides access to the Florida Department of Law Enforcement’s database of those who have committed crimes against animals. Most notably, such access is critical to animal adoption organizations to ensure that perpetrators are disqualified as recipients of animals seeking placement.

As a member of the Florida House of Representatives in 2018, Leek served as the prime sponsor of House Bill 473, which revised classifications of certain animal cruelty offences and authorized courts to prohibit violators from owning animals. Known as “Ponce’s Law” the measure honored

the 9-month-old Labrador retriever puppy named Ponce who was found beaten to death in Ponce Inlet.

“Thank you to Sen. Tom Leek for filing Senate Bill 502 and Senate Bill 494, which will further advance our shared mission in giving a voice to those who cannot speak for themselves,” said Debbie Darino, president and founder of The Ponce Animal Foundation, Inc., a 501(c)(3) non-profit organization. “This legislation will rightfully increase punishment to those who dare to mistreat our beloved animals.”

In addition, Leek filed in January SB 234: Criminal Offenses Against Law Enforcement Officers and Other Personnel, known as the “Officer Jordan Raynor Act,” in honor of Daytona Beach Police Department officer Jason Raynor who was killed in 2021 in the line of duty, and this week, SB 466: Florida Museum of Black History in furtherance of Florida’s Museum of Black History by creating a board of directors to oversee the commission, construction, operation and administration of the museum. The Florida Museum of Black History Task Force selected St. Johns County as the preferred location for the museum.




said. "Fast forward to the Skin Spa and our main emphasis is on not only achieving results but providing an exceptional guest experience."

Managing Aging Parents' Finances: What to Know in 2025

Making financial decisions takes time, attention and energy at any age. In the case of elderly adults, it may become increasingly difficult to manage finances, particularly if their health is declining or they're experiencing a cognitive issue. If you're providing support to aging parents — or plan to in the future — here are some tips on how to handle the situation and prepare for what's to come.

Don't wait to start talking about money. While it may be uncomfortable to ask your parents to discuss their finances with you, it's essential that you are familiar with their intentions for future care and what plans they have in place. The first time you broach the subject, emphasize that you are looking for only a high-level overview so that you can have more peace-of-mind that your parents will be well cared for. This initial conversation can help set the groundwork for future discussions.

Create a contact list. If your parents experience a sudden change in their health that affects their ability to manage their own affairs, it's important to have a game plan for what happens next. If you anticipate stepping in to pay bills, make insurance claims and handle other financial tasks, start by asking your parents


for a list of contact information for the professionals they work with and where their accounts are held. Keep in mind that you may need to be an authorized user or power of attorney to be allowed access to certain accounts. Consult a lawyer to talk through what permissions may be necessary for you to step in if the need arises.

Build a support network. Talk with siblings or other trusted family members about what a possible care plan could look like for your parents. While this conversation can be tough to initiate, know that it's often easier to bring everyone together while your parents are still healthy and in good mental capacity. Discuss who can realistically provide support — and in what way and at what cost. Proactively deciding who can drive your parents to doctor appointments, manage financial affairs, care for their home and handle other tasks can help avoid a strain on your time and energy down the road.

Anticipate future lifestyle changes and challenges. Even if they aren't yet needed, explore the options and costs of various assisted living and memory care services. Check your parents' insurance policies to see if and how services might be covered. You may also want to explore whether their home or yours could be modified to provide additional space or comforts, such as wheelchair access. Knowing what choices exist and how your parents feel about each one can help you make future decisions with more confidence.

Know your rights at work. The Federal Family and Medical Leave Act of 1993 (FMLA) allows covered employees up to 12 weeks of unpaid leave to provide care for a family member with a serious health condition.¹ Consult your Human Resources department to learn what your company's policies are for employees who are caring for a parent and how to initiate a claim if you need to. Many employers have access to resources and support groups to help you manage your responsibilities at home and at work.

Maintain momentum on your own financial goals. It's understandable to



want to provide your parents with as much support as you can. It's prudent to look at your finances to see how much support you could provide, if that is needed, without jeopardizing your own retirement and future health care needs.

It's hard to imagine — let alone talk about — what caring for an ill or aging parent may look like. For additional support in having family conversations, evaluating financial options and creating a plan for your parents, contact your financial adviser and lawyer. These experts work day-in and day-out with families in similar situations and can help you take the steps necessary to feel more confident about your own plan.

Mother Holistic offers alternative healing for body and mind

Jacksonville Beach small business owner Joey Jennings opened his store, Mother Holistic, not only to educate the community about the healing properties of hemp but also to offer an alternative to commercial pharmaceutical drugs.

Mother Holistic opened its doors in 2018, a few short years after Jennings left his corporate job as a financial adviser and embarked on a holistic healing journey across the world.

“I was using pharmaceutical drugs for many years to manage my pain, which started to affect me not only physically but mentally,” Jennings said. “I reached a

point where I realized I couldn’t continue living life like this. So, I knew I needed to make a change.”

He took a leave of absence, traveled to countries in Central and South America, and participated in plant-based medicine retreats to help find a solution for his pain. When Jennings discovered CBD, it was as if a whole new world of possibilities unfurled before him.

“I was familiar with cannabis, but I didn’t think there was a non-psychoactive side to it,” he said. “I was intrigued and went down the rabbit hole, studying about cannabis plants and the compounds in the plants.”

After more than six months of immers-

Benefits gap for older adults being studied

The National Council on Aging (NCOA), the national voice for every person’s right to age well, has received a \$250,000, one-year grant from the Robert Wood Johnson Foundation to examine what contributes to high enrollment rates of older adults in benefits programs in Miami-Dade County, Florida, and Duval County, Texas.

Through this work, NCOA seeks to understand what is working in two counties that enroll exceptionally high percentages of older adults in the Supplemental Nutrition Assistance Program (SNAP), Supplemental Security Income (SSI), and Medicare Savings Programs (MSP):

SNAP

- Miami-Dade County: 50%
- Duval County, Texas: 43%
- National rate: 30%

SSI

- Miami-Dade County: 90%
- Duval County, Texas: 83%
- National rate: 49%

MSP

- Miami-Dade County: 79%
- Duval County, Texas: 100%
- National rate: 46%

“It’s heartbreaking to see that millions of eligible older adults who could really use this help are not enrolled in these programs,” said Ramsey Alwin, NCOA president and CEO. “We want to see what these two counties have done to generate such high enrollment rates, so other counties and states can replicate their success together with local providers and federal policymakers.”

SNAP helps participants afford food, SSI provides monthly cash assistance for older adults and people with disabilities

and the MSPs help people with Medicare pay for their health care costs. Often, these programs can be the difference between an older adult having to choose between food or medicine each month.

NCOA will produce and disseminate a best-practices report with recommendations for county, state and federal policymakers as well as community-based organizations, which they can use to help more older adults enroll in public benefits programs.

NCOA’s Benefits Participation Map, an interactive tool that shows county-level data for enrollment in these key programs, reveals wide variations across counties when it comes to how many eligible older adults are receiving these valuable benefits. Nationwide, almost 9 million eligible older adults are not enrolled in SNAP, 2.3 million are not enrolled in SSI, and almost 5.8 million are not enrolled in MSP.

The map shows that St. Johns County

has a SNAP participation rate of 19.5% and 6,273 eligible nonparticipants. It’s SSI participation rate is 33.6%. It’s MSP participation rate is 26.8%, with 4,673 eligible nonparticipants.

The map shows that Duval County has a SNAP participation rate of 44.4% and 22,505 eligible nonparticipants. It has a 44.2% SSI participation rate with 6,988 eligible nonparticipants, and it has a 56.8% MSP participation rate with 12,550 eligible nonparticipants.

“The effectiveness of the social safety net in reducing hardship depends to no small degree on adequate outreach and the simplification of enrollment,” said Katherine Hempstead, senior policy adviser, Robert Wood Johnson Foundation. “We are excited to support NCOA in its effort to lift up best practices to increase take-up of important benefits among older adults.”







Millions at risk for AFib by 2030: How you can stay ahead

February is American Heart Month, and it's a great time to learn about atrial fibrillation, or AFib, a condition that affects millions of people each year. AFib is the most common type of heart arrhythmia, and it can increase the risk of stroke by five times and double the risk of heart-related deaths. Unfortunately, many people don't even know they have it because AFib often doesn't show any symptoms.

Currently, between 2.7 million and 6.1 million people in the United States are living with AFib, and the Centers for Disease Control and Prevention (CDC) estimates that this number will rise to 12.1 million by 2030. That's why it's so important to recognize the signs of AFib — for yourself and your loved ones. Early detection can make all the difference.

Recognizing the Symptoms of AFib

Not everyone with AFib has obvious symptoms. In fact, some people only discover they have the condition during routine screenings. However, if symptoms do appear, they can include an irregular or rapid heartbeat, lightheadedness or dizziness, shortness of breath, confusion, extreme fatigue and chest discomfort. If you notice any of these symptoms, it's important to consult a health care provider for further evaluation.

Understanding the Different Types of AFib

AFib comes in several patterns, each of which can require different approaches for treatment. Paroxysmal AFib occurs in episodes, starting and stopping on its own. Persistent AFib lasts longer than a week and typically needs medication or cardioversion (a procedure to reset the heart's rhythm). Long-standing persistent AFib lasts more than a year without interruption. Lastly, permanent AFib is continuous, and treatment focuses on controlling the heart rate rather than attempting to restore normal rhythm.

What Causes AFib and Who Is at Risk?

Several factors contribute to AFib, including aging and stress on the heart. Certain conditions increase the risk of developing AFib, including obesity, high blood pressure, sleep apnea, coronary artery disease and diabetes. Family history can also play a role. Lifestyle choices, such as smoking, excessive alcohol use and high stress can also increase the risk.

Treatment and Prevention: Keeping Your Heart Healthy

While AFib cannot always be prevented, there are several ways to keep your heart healthy and reduce the likelihood of developing it. Lifestyle changes, including maintaining a healthy weight, keeping alcohol intake at low levels (none or under one drink per day), treating sleep apnea, managing blood pressure, staying active and avoiding smoking can significantly reduce your risk.

For those diagnosed with AFib, treatments may include blood thinners to reduce stroke risk, medications to control symptoms and procedures like catheter ablation or cardioversion to restore normal rhythm. If you suspect you may be experiencing AFib, it's important to speak to your doctor.

This February, in recognition of American Heart Month, take the time to care for your heart and encourage your loved ones to do the same.

The Recorder's garden columnist, Kathy Esfahani of Kathy's Creative Gardens & Nursery, shares her tips for growing gorgeous gardens in Northeast Florida.

KATHY'S GARDENING GUIDE

Dianthus

"Love is like a flower — you've got to let it grow." — John Lennon

Symbolizing admiration, happiness and love, the dianthus flower is blooming now, just in time for Valentine's Day! These fragrant plants make beautiful gifts on their own or combined with other flowers in colorful bouquets. They are

wonderful as splashes of color in a planter or garden and useful as bright borders to outline a landscape bed.

Dianthus flowers are available in pinks, purples, reds and whites and have delicate blooms featuring five petals with fringed edges. These blooms can be a single color or multicolor. The blue-green leaves of dianthus are long and thin, almost like blades of grass. Dianthus grows in clumps and varies from small groundcover plants to stems 30 inches tall.

Although dianthus can tolerate partial shade, it is best to plant them in areas of full sun (at least six hours per day). Prepare for planting by digging a hole twice the

size of the plant's root ball. Space the plants at least 6 inches apart and use only a thin layer of mulch if any at all. It is important for the stems to have ample room for air circulation.

Dianthus prefers well drained soil, even bordering on slightly dry. Wait for the soil to feel dry to the touch before watering. Yellow leaves may be a sign of too much water! Remove old blooms and leaves to encourage growth throughout the season.

Dianthus blooms bring birds, bees and other pollinators to the garden — enjoy watching the hummingbirds and butterflies that dianthus may attract.

The leaves and stems of dianthus plants should not be ingested and can be mildly irritating to human skin. Be sure to wear gloves when working with these plants and wash irritated skin with soap and water. Dianthus can be toxic to animals if eaten, possibly causing nausea, vomiting or other digestive issues. Look for areas safe from roaming animals and children when planting dianthus.

However, when grown organically, the blooms of dianthus plants have both medicinal and culinary uses. They can be used as herbal diuretics or applied to the skin to treat infections or swelling.

Dianthus blooms are edible for humans and often used

as culinary garnishes. In ancient Rome, dianthus flowers were used to flavor oils and wine. Their spicy fragrance and taste can add interest to salads, cake decorations or syrups.

Whether decorating a romantic plate or starring in a beautiful bouquet, dianthus flowers are perfect for celebrating love!

Why rebalancing can be so important

Imagine sitting in a rowboat and wanting to get back to shore. If you just sit there, the wakes from passing boats and the wind could cause you to drift further toward the middle of the lake — not where you want to be. Of course, they might actually move you toward the shore. Who knows?

On the other hand, you could use your paddles. It's more work, but it'll increase the possibility of your reaching your destination.

It's similar with your portfolio. If you neglect it, market activity may cause it to drift away — possibly far away — from where you want it to be.

Take, for example, a portfolio that starts out 60% stocks/40% bonds. If stocks were to have a particularly good year and bonds a bad one, the allocation could shift to, say, 70% stocks/30% bonds without the investor even realizing it. While this portfolio likely has better growth potential than the original, it could also take a bigger hit if stocks, which tend to be more volatile than bonds, turn around and have a bad year.

To help avoid this, you should consider periodically “rebalancing” your portfolio. This involves looking at how you're diversified across different types of investments and considering selling some investments and buying others when necessary to bring your portfolio back to the asset allocation you originally intended. In the example above, you might think about selling stocks and buying bonds to get to 60% stocks/40% bonds.

Educator studies monarch butterfly migration in Mexico

Dream trip granted by Wish of a Lifetime from AARP

When Peggy Campbell-Rush was 6 years old, she became so enamored of the hundreds of monarch butterflies flitting around the family's cottage on Long Beach Island that her mother bought her

a net. She spent the day catching these winged wonders but was immediately faced with a decision: what to do with them.

"I put them in our little, teeny bathroom," she said, laughing. "Then, my father came home, and he opened the door with a flourish, and all of them flew out!"

How many had she collected? Apparently, a lot. The family spent the next

four to five hours returning them to the outdoors.

The experience launched a lifelong fascination with the monarch, one that found a home years later in Campbell-Rush's career as an educator introducing her kindergarteners to these brilliant creatures.

"I would actually raise them and bring them into the classroom and have the children watch the caterpillars grow on the milkweed and then form a chrysalis

and then transform and metamorphose into the butterflies," she said. "Then, we would release them together."

Raising monarchs means planting milkweed, which is necessary for the butterflies to lay their eggs and the larvae to eat, and nectar plants to attract mature members of their population. Campbell-Rush made her yard into a habitat and



got it registered with Monarch Watch as a monarch waystation.

The monarch remained a constant interest for Campbell-Rush over the years — throughout her time as head of The Bolles Lower School Ponte Vedra Beach Campus from 2014 to her retirement in 2020 and her battle with stage 3 breast cancer as a young woman.

But there was one great experience prized by butterfly lovers everywhere that eluded her: A visit to the overwintering site just as millions of monarchs prepared to take wing in one of nature’s grandest wonders, the annual 3,000-mile migration from Mexico to Canada.

Now, in her golden years, Campbell-Rush’s opportunity has arrived, thanks to Wish of a Lifetime from AARP.

Reading the AARP magazine one day at the beach, she discovered stories about people who had been granted lifelong wishes through the affiliate organization, Wish of a Lifetime. So, she applied, was interviewed and was granted her wish.

She has now joined a group comprised entirely of women on a scientific and photographic journey in the mountains of Central Mexico where the monarchs

winter among the oyamel fir trees, more than 7,000 feet above sea level.

“I cannot wait!” she exclaimed last week before departing. “This is just a miracle. . . . Can you imagine doing this your whole life and then having this opportunity?”

“We love to see these wishes come true,” said Wish of a Lifetime’s Southeast Field Representative Natasha Hartsfield. Last year, her region granted 273 wishes. Nationwide, the organization has granted about 3,000 wishes since its founding in 2008.

“We grant experiential wishes for people 65 and older to bring hope and joy and to inspire others,” Hartsfield said.

Interested people can apply to the program at wishofalifetime.org. They can nominate themselves or someone else, but the wish must meet certain criteria. It must have a compelling story. It must impact lives.

For Campbell-Rush, it was the fulfillment of a lifelong dream, something that will enrich her mission to continue educating children and adults.

Today, Campbell-Rush advocates for at least three things: get a mammogram, something she said saved her life; plant milkweed and flowers to help monarchs in their migration; and “keep wishing, no matter how old you are.”





Celebrated musicians to perform free concert

An art exhibit follows at the reception with paintings and sculpture by Swedish artist Åke Arnerdal.

Zuill Bailey, widely considered one of the premiere cellists in the world, is a Grammy Award-winning, internationally renowned soloist, recitalist, artistic director and teacher. His rare combination of celebrated artistry, technical wizardry and engaging personality has made him one of the most sought after and active cellists today.

Bailey has been featured with symphony orchestras and music festivals world-

wide, has appeared in a recurring role on the HBO series "Oz" and has been heard on several NPR programs.

Grammy-winner Jason Vieaux, "among the elite of today's classical guitarists" (Gramophone), is described by NPR as "perhaps the most precise and soulful classical guitarist of his generation."

Sought-after for his extensive concerto repertoire, Vieaux has performed with a

long list of orchestras and has an extensive discography.

In 2011, Vieaux co-founded the guitar department at the Curtis Institute of Music (with David Starobin). He has taught at the Cleveland Institute of Music for 25 years.

Åke Arnerdal divides his time between Torsåker, Sweden, and Jacksonville. He has exhibited at various venues around the world.

Concert to feature music by Dvorak, Florence Price

The Florida Chamber Music Project (FCMP) will perform Florence Price's String Quartet in G Major (Unfinished) and Antonin Dvorak's String Quartet in G Major, Op. 106 at 3 p.m. Feb. 23 at the Beaches Museum Chapel. The concert is sponsored by Holly and Redgie Gutshall.

Florence Price is noted as the first African-American woman to be recognized as a symphonic composer, and the first to have a composition performed by a major orchestra (the Chicago Symphony). She has composed more than 300 works. Her training was steeped in the European tradition, but her music reveals her Southern roots. It's said she uses all of the instruments of the quartet well, especially the cello. This piece, String Quartet in G Major (Unfinished) is considered one of her most beloved pieces and shows the influence of Dvorak and other late Romantic composers formally and harmonically while bearing the distinct stamp of the African-American spiritual tradition.

String Quartet in G Major, Op. 106 by Antonin Dvorak was composed in 1895 and first performed in 1896. The piece contains four movements, beginning with a playful,

fluttering theme that's followed by a remote theme and counter melody. This quartet is defined by its lyricism and exciting rhythmic vitality. It's said that this piece conjures a dialogue along the lineage with the voices of Haydn, Beethoven, Schubert and Brahms.

"Florence Price and Antonin Dvorak were alive at the

same time and were influenced by some of the same music," said FCMP Artistic Director Susan Pardue. "Florence Price admired the music of Dvorak, and the influence of that is audible in her music. Dvorak appreciated the music of African-American spirituals, even borrowing some of his material from the melodies of these spirituals. It is somehow fitting that Florence Price was from the community from which the music was borrowed and then she used some of it in her compositions as well."

Tickets are \$30 at the door or through 904TIX. Student tickets are \$10 and available only at the door.

Beaches Museum Chapel is wheelchair-accessible and has free parking along Pablo Avenue near 4th Street North of Beach Boulevard. All concerts begin at 3 p.m. Attendees are invited to join the musicians after the concert for refreshments.

The Florida Chamber Music Project was founded 12 years ago by violist Susan Pardue. Joining her are violinists Patrice Evans and Ann Hertler and cellist Laurie Casseday. All are members of the Jacksonville Symphony.

First Coast Cultural Center’s President Guzzo to retire


Donna Guzzo has announced her retirement as president and CEO of First Coast Cultural Center beginning Feb. 28, and a replacement has yet to be named.

we did "Les Misérables," and they did great, so I wanted to see if they can take it one step further. Sometimes that's the only way you can grow, is when you're outside your comfort zone."

According to Nettle, there are many aspects that go into making such a production possible behind the scenes.



Amateur team wins 34th Underwood Cup

The Northern PGA Chapter Professionals had visions of another dramatic comeback in this year's 34th Annual Underwood Cup hosted by Deerwood Country Club in Jacksonville on Feb. 3 and 4, just as they had done a year ago.

However, their amateur counterparts were having nothing to do with a repeat of what transpired last year when the amateurs had a big lead only to watch their then 8 ½-3 ½ advantage slowly slip away during the singles matches on the final day as the pros completed a historic rally to claim the top prize by one point.

In the end this time around, the amateurs defeated the professionals by a score of 14-10, which gave the amateurs their 19th victory in the more than three-decade history of the Underwood Cup, which has a unique format, like the Ryder Cup, pitting the top Northern Chapter PGA professionals against a team of elite First Coast amateur golfers.

The amateurs got off to a quick start during the two-day tournament and grabbed a commanding 9-3 lead with stellar performances in morning four-some and afternoon four-ball competi-

tions on the first day.

For the second year in a row, the professionals applied some early heat when Stephanie Connelly-Eiswerth, Hayes Farley and Michael Mattiace won three of the first four matches, convincingly –

5&4, 4&3 and 5&4, respectively.

“We had hope at that point,” said pro captain Mike Broderick, the head professional at Deerwood Country Club. “It was getting real. Stephanie set the tone for us, Mike (Mattiace) and Hayes (Far-

ley) won big matches. We were close in a lot of other matches. We thought it was possible.”

Connelly-Eiswerth was particularly impressive and motivational in her lead match versus the reigning Florida men's amateur champion, Jimmy Ellis of Atlantic Beach Country Club.

The 2024 PGA of America Women's Professional of the Year reeled off a string of birdies to get to eight-under and the match was called at the 14th green.

The twosome would play out the round with Connelly-Eiswerth adding two pars and two birdies on the last four holes for an unofficial round of 62 (10-under).

“At one point I was standing [where he could see three holes] and all I saw were the pros making birdies,” said amateur captain Mike Del Rocco. “They started out fast. We had guys playing well but they were playing better.”

Dean Grunewald, director of golf at The Plantation in Ponte Vedra Beach, has been named captain of the professional team in 2026 followed by Broderick in 2027. The amateur team has yet to select its next captains.

Sharks, Barracudas claim convincing basketball district titles

The Ponte Vedra High and Beachside High basketball programs earned district titles and now eye a possible state title to go in the trophy case.

The Sharks' boys basketball squad defeated St. Augustine High 49-30 in an all-St. Johns County battle to claim the district 4-5A championship, while the Barracudas won the girls basketball crown defeating the Sharks with a convincing 73-34 victory.

It was the Sharks' defense that proved the difference in the boys championship as it was able to stymie the methodical Yellow Jackets' offensive attack and held them to their lowest point total of the season.

Maddox Palmer had a game-high four steals, as the Sharks had nine steals on the night and forced the Yellow Jackets



into 14 turnovers.

Palmer and David Sanchez Barrera both led the Sharks with 14 points and Trace Westercamp finished one point shy of posting a double-double with nine points and 11 rebounds.

It was the eighth straight win in their series against the Yellow Jackets.

The Sharks earned the No. 2 seed in region 1-5A and hosted No. 7 Pensacola Booker T. Washington High in the first round on Wednesday, Feb. 12, at 7 p.m. The score was not available by press time, but with a win, the Sharks would play either No. 3 Gainesville High or No.



6 Lake City Columbia at home on Monday, Feb. 17 at 7 p.m.

In the girls championship, the Barracudas proved time and again that they were clearly the best team in the district and that was reflected during the district tournament, when they won both their games by an average margin of 36.5 points, as they defeated Riverside High 60-26 in the district semifinal prior to their blowout win over the Sharks.

Senior Kendall Kane and junior Morgan Cremen both had a huge tournament scoring and proved hard to defend,

especially from long range.

Kane reached the 20-point mark in both games and was on fire against the Sharks, shooting 67% from the field on 12 shots.

Cremen tallied 16 and 19 points in the two games, respectively, and together with Kane the two combined for 13 three-pointers during the tournament.

Junior Anni Ament was a force rebounding and freshman guard had a breakout game against the Sharks in the championship with 15 points on a perfect night shooting, as she knocked down all six of her shot attempts.

As district champions, the Barracudas slot in as the No. 3 seed in region 1-5A of the girls basketball state tournament and will host No. 6 Orange Park High in the first round, while the Sharks make the playoffs as a No. 8 seed and will travel to take on top-seeded Pensacola Booker T. Washington High.

Both games will be played on Thursday, Feb. 13, and begin at 7 p.m.




