





# School districts respond differently to federal directive on transgender restroom, locker room use

The Duval, Clay and St. Johns county school districts have all adopted different stances on the Obama administration's recent directive stating that school districts that don't allow transgender students to use bathroom and locker room facilities consistent with their gender identity risk jeopardizing their receipt of federal funds.

In an eight-page letter sent jointly by the Department of Justice and Department of Education, the Obama administration noted that "as a condition of receiving federal funds, a school agrees that it will not exclude, separate, deny benefits to or otherwise treat differently on the basis of sex any person in its educational programs or activities"

With regard to school restrooms and locker rooms, the letter stated, "A school may provide separate facilities on the basis of sex, but must allow transgender students access to such facilities consistent with their gender identity."

#### **Local response**

After Duval County pledged to comply with the federal directive, a lawsuit

was filed by state attorney candidate Wes White on behalf of a mother of four Duval County public school students. In Clay County, meanwhile, Superintendent Charlie Van Zant Jr. posted a YouTube video assuring parents that the school district would not follow the directive.

"This direction from the Obama administration does not carry the force of law," Van Zant said, "and you can be assured that we will not allow the intrusion by the federal government into your child's school life."

Saying that he had received an "outpouring of concern" over the issue, Van Zant added that "biologically male and female students will be required to use their respective bathrooms, locker rooms and other facilities made available for their personal use."

The response by the St. Johns County School District was less definitive. In a statement issued last week, Superintendent Joseph Joyner said, "I am committed to doing what is right for each and every child. We believe our current practice is lawful and reasonable in that we provide gender neutral restroom facilities to accommodate

#### Jacksonville man drowns at Ponte Vedra beach

A Jacksonville man drowned at the beach at Guana River State Park Sunday.

Robert O. Hickson, 29, was on the beach with family members at 5:45 p.m. Sunday when another family member swimming in the ocean appeared to be in distress. According to witnesses, Hickson went into the water to assist the family member but went under and disappeared.

An extensive water and shore search was undertaken by the St.

Johns County Sheriff's Office, St. Johns County Fire/Rescue personnel, F.W.C., the U.S. Coast Guard and a helicopter from Lifeflight. The search later became a recovery operation, however, when the sheriff's office Beach Patrol Unit located Hickson's body Monday morning in the surf approximately one-quarter mile south of where he last had been seen. The district medical examiner conducted an autopsy and the sheriff's office Major Crimes Unit continues to investigate.

# TPO presents proposed traffic improvements

Study recommendations draw mixed reviews from residents

Maintaining three south-bound lanes from Marsh Landing Parkway to Marlin Avenue, adding bike lanes along Marsh Landing and South Beach parkways and constructing a Florida T-intersection on SR A1A at Ponte Vedra Lakes Boulevard are among the traffic and safe-ty improvements proposed in a new study by the North Florida Transportation Planning Organization (TPO).

TPO officials presented the study's recommendations to a standing-room-only crowd of local residents at a meeting held May 17 at the Ponte Vedra Beach Branch Public Library. TPO Executive Director Jeff Sheffield and HNTB Transportation Engineer Jennifer Kennedy walked attendees through the \$4 million in recommended inprovements in the study, which examined six intersections in the North Ponte Vedra Beach/Jacksonville Beach areas:

- J. Turner Butler Boulevard (JTB) and Marsh Landing
- Marsh Landing Parkway at South Beach Parkway
- Sanctuary Parkway a South Beach Parkway
- Ponte Vedra Lakes Boulevard at Marsh Cove Drive
- Marsh Landing Parkway at SR A1A
- Ponte Vedra Lakes Boulevard at SR A1A

As part of the study, Kennedy said, engineers compared existing conditions at these intersections with traffic and safety projections in 2040. A variety of alternatives were considered for each intersection with a goal toward improving both safety and traffic flow, with engineers ultimately coming up with a list of recommended improvements for

each intersection.

"I know you won't agree with everything – we're used to that," Sheffield said. "The goal was to look at solutions in the context of safety and traffic improvements."

One finding that elicited both surprise and questions from the audience was TPO's recommendation that the intersection of JTB eastbound and Marsh Landing Blvd. remain as is, with no improvements. All of the considered improvements, representatives, said, created backups onto JTB.

"To take the position that nothing can be done is something we take exception to," said Bob Golitz of the North Ponte Vedra Beach Coalition, the group that initially requested the study. "If you can put a man on the moon in a decade, you can fix the problems at that intersection."

Golitz said that members of the coalition – which is comprised of residents from Marsh Landing at Sawgrass Master Association, Ponte Vedra Lakes Owners Association and the Marsh Landing Business Park Owners Association – are also split regarding their views on the recommendation to extend South Beach Parkway to Ponte

struction of a Florida T-intersection, for example, would include having two northbound lanes with constant green lights.

"I live on Avenue C," one

resident said. "How do you expect us to get out of our neighborhood and go south if we have to cross two lanes of traffic that have constant green lights?"

"(The proposed solution) does create what you're saying," Sheffield confirmed. "We looked at this purely from an engineering standpoint."

Other residents pointed out that some of the study's recommendations – including building a neighborhood park, school bus bays and a parking lot along Ponte Vedra Lakes Boulevard – involve privately owned roads. That discussion prompted Sheffield to stress that no funding has been allocated for any of the proposed improvements.

"We were asked to do an evaluation and that's what we're doing," Sheffield said. "Funding is a completely different conversation."

Should the recommendations move forward, he added, funding could come from a number of governmental sources at the county and state level. The first step, he said, was gaining input from the community on the initial recommendations. At the meeting, TPO representatives passed out comment cards for attendees to complete.

Golitz of the North Ponte Vedra Beach Coalition encouraged attendees to contact the coalition and share their views.

"We as a group have to come with a strong voice, with one voice," he said. "We have to collectively come to terms with what our traffic and safety concerns are"

privacy and safety for all students as needed or requested.

"There has been no binding decision made on schools in Florida and I, along with our school board, will continue to follow the development on this guidance and make adjustments to our current practice only if necessary," the statement continued. "Again, my focus remains on the needs of the individual child."

A St. Johns County School District spokesperson declined requests for further comment or clarification on how the district currently provides gender-neutral facilities, or whether that policy is in conflict with the White House's directive, which states, "A school may not require transgender students to use facilities inconsistent with their gender identity or to use individual-user facilities when other students are not required to do so"

# County Commissioners approve Nocatee plan modifications

The Board of County Commissioners unanimously approved a number of technical modifications to Nocatee's comprehensive plan and PUD last week, changes the developers say will give them the flexibility to respond to changing market conditions.

In addition to approving The PARC Group's request to decrease the percentage of multi-family units and provide more flexibility with regard to the siting of schools, commissioners approved a number of other technical modifications, including those related to the development of new southern neighborhoods within the master-planned community. As was the case when the matter came before the Planning & Zoning Agency last month, however, it was the proposed modifications to affordable housing provisions on which commissioners focused most of their discussions.

"This county adheres to federal guidelines for providing affordable housing," Commissioner Jimmy Johns said. "I want to make sure we haven't painted ourselves into a box by limiting our options."

Previously, the developers had agreed to donate 50 acres of land in Nocatee for affordable housing development, along with \$800,000 over time. But while the developers have to date given \$150,000 and 10 acres of land toward that commitment, the county has yet to develop any affordable housing on the property in the decade since it was donated – a fact that seemed to surprise and dismay county commissioners.

"So we've had that affordable site for 10 years and so far nothing's happened?" Commissioner Rachael Bennett asked. "I would really like to see us get something going on that site...Ten years is a long time to sit fallow."

Commissioner Bill McClure agreed. "I'm not happy to hear we've had (the land) since 2006 and we haven't really done anything with it," McClure said.

Under the now-approved modifications, instead of donating the remaining 40 acres of land and continuing to make cash payments over time, the developers would make immediate payment of the remaining \$650,000 and donate 20 acres of more valuable land on Nocatee Parkway for development as a private post-secondary institution. If after five years the school had not been developed, the developers would pay the county \$1.64 million in return for retaining the 20 acres.

"We believe the proposed changes... are of mutual benefit to the county and Nocatee," said Ray Spofford, who represented The PARC Group at the commission meeting. "Nocatee will be able to respond better to changing market conditions."

County planning officials also supported the change, saying that the immediate cash payment would allow the county to address a number of current affordable housing challenges.

"This is an overall good deal for St. Johns County and the citizens of St. Johns County," Planning Division Manager Teresa Bishop said.

Three county residents spoke in opposition to the change, however, citing the need to provide affordable housing for police officers, firefighters, teachers and others who might work in Nocatee.

"I don't buy the fact that market conditions have really changed," St. Johns resident Ellen Whitmer said. "The name of the game is to maximize profits. I'm in opposition."

Commissioners, however, noted that many of the homes built in Nocatee met the standard for affordable housing. In addition, the construction of 9B and planned commercial developments along that corridor have changed the development landscape significantly since Nocatee was first envisioned and approved.

"Take it from someone who's had a beautiful condo sitting on the market for over a year," Bennett said. "The multifamily market is not here. So market conditions do change.

"Our world was a different place 15 years ago than it is now," she continued. "I think it's important that we realize that as times change, we need to make sure we're not trying to force something to fit that no longer fits."

# Patrick Caulfield

#### How did you come to be involved as a PLAYERS volunteer?

A friend of mine introduced me to a friend of his at a party by the name of Tim who worked for the tour. He suggested that I volunteer with the tournament. So I did and that was in 1985. Since then, the tournament has provided funds to several other charities that I have been involved with. I see it as a win – win.

#### What are your responsibilities as media center chairman?

My primary duty is to oversee the media center. I have two assistant chairmen – Al Herndon and Tom Hyde – and a total of 15 volunteers in the media center. The media volunteers are there to give assistance to the media, including photographers, with any of their needs. This includes checking the media in, assisting with interviews, providing copies of player's interviews, photo shoots, transporting the media from one place to another, working with Getty Images, etc. Basically, anything that the media needs, we will assist them with if at all possible.

#### Describe a typical day volunteering there.

A typical day for Al and me normally starts around 3 a.m. Tuesday through Friday – 5 a.m. on Saturday and Sunday – and ends about 1 to 2 hours after play. We normally pick up local news teams along with local radio personnel from the media parking lot and bring them into the tournament so they can set up for their live shots and radio shows. The other volunteers come in at 7:30 a.m.

We go through all newspapers, for example, *The Times Union, The Record, Beaches Leader, USA Today, New York Times, New York Post,* etc. All articles that mention The Players are cut out, copied and assembled in a package and are available to all the press.

As the media comes into the tournament starting on Monday, we make sure they have their credentials, parking passes, etc. We help with the interviewing of players by making sure that copies of the interviews are available to all the media as soon as they are transcribed. We also transport photographers and other media to wherever they need to go throughout the golf course, assist in transporting any VIPs or charity groups and make sure that at the end of the day, all stat packages are assembled and available to all the media.

#### What is the biggest challenge of volunteering in this capacity?

One of the largest challenges is the amount of media we deal with and some of the time elements that we are involved with. At any point during the day, we may be called upon to act or react to certain situations that may need our immediate attention. Time may be a huge factor. We just have to be ready to respond. We have a great group of volunteers that always comes through under pressure.

#### What is your favorite part of being a volunteer for THE PLAYERS?

My favorite part of being a volunteer is the people that I work with. The tournament staff that I work with are incredible: Denise Taylor, Chris Reimer, Laura Neal, Joel Schuchmann and others are wonderful to work with. And the media center volunteers: I couldn't ask for a better group of people to work with both on my committee and other committees. All these people make it fun and enjoyable.

#### What do you enjoy doing in your free time?

I enjoy traveling and playing golf. I also volunteer at Mayo.



## Annual luncheon honors community nonagenarians, centenarians

Thankful, grateful and blessed – all three were common themes among the nonagenarians and centenarians honored at the annual St. Johns County Council on Aging Centenarians Luncheon, held at The Players Community Senior Center May 18.

This year's honorees included a group of 17 nonagenarians – people aged 90 to 99 – and five centenarian honorees aged 100 and over. Sponsored by the Ponte Vedra Beach Rotary, the event featured Rotarian and COA Board Member Bruce Barber as master of ceremonies.

Barber opened by mentioning a few facts from 1916 – that World War I was the main news topic and the "it" star of the time was Charlie Chaplin.

The luncheon was served by the Landrum Middle School IMPACT club.

"This is their favorite event all year," said Cherie Anthony, Landrum Middle School dean of students and IMPACT club sponsor. Of the 12 middle schoolers volunteering for the event, two also volunteered at last year's luncheon. Their presence was appropriate to another topic of discussion at the luncheon – that of bridging the gap between youth and seniors.

Ponte Vedra Baptist Church Pastor Bob Loy, who delivered the invocation, remarked that the future is in the hands of senior adults and with that comes the responsibility to impart their wisdom to younger generations.

"Tell your story – tell it to younger generations over and over again," Loy said. "The younger generation, they need to hear what you have to say."

One by one, the honorees were recognized and given a chance to share their words of wisdom or their secrets to staying young.

Ninety-five-year-old Arne Nielsen disclosed that his secret to staying youthful was singing every morning when he wakes up. He then serenaded the assembly and was given a resolute round of applause for his performance.

His 93-year-old wife, Marilyn Nielsen, was also one of the honorees.

"Arne and I are blessed," she said.
"We're the only couple here over 90."

Music has been an important factor in 95-year-old Ruth Conley's life as well.

"My mother was a professional musician, so I've been fortunate enough to grow up with the most wonderful music in the world," she said, and with that, she also recognized the talent of pianist Don Miniard, who played at the luncheon

Many of the honorees were not native to Florida, and not all were long-time residents of Ponte Vedra either, but 100-year-old Hana Delli-Gatti drew special recognition for being one of the first residents of the Ponte Vedra Beach retirement community Vicar's Landing 26 years ago. She recalled watching the

community being built.

"Tve lived in Vicar's Landing as long as they've been there," she said. "I can remember them tying little red ribbons on the trees that they were going to cut down."

Fellow centenarian honoree Marion Hayes, 102, owned a vacation home in Ponte Vedra with her husband, and when he died, she decided to remain here. She credits her family, which consists of three children, 10 grandchildren and 20 great grandchildren, with keeping her young at beaut.

"It's my family that has kept me going, and I'm delighted that I'm 102 and about to be 103," Hayes said. "I'm happy, and that's the reason I keep going."

were well-established at The Players Community Senior Center, such as 102-year-old Minna Barnes, who has lived in Ponte Vedra since 1954.

Another centenarian honoree, Marie Lund, also utilizes the senior center. Over the past couple of years, she has been taking the senior center's tai chi class with class instructor Dennis Sheils.

The only male centenarian honoree was 100-year-old James Jackson, a World War II veteran who relocated to Ponte Vedra after his wife died and lives with his daughter and her family. Jackson has a very straightforward secret to his endurance.

"They say to me, what's your secret? It's no secret," he said. "You just have to keep breathing!"

St. Johns County Council on Aging Executive Director Becky Yanni was impressed by the seniors' optimism, expressed by the common themes in how they perceive life.

"It's inspiring to talk to the people who have reached this kind of milestone," Yanni said. "They really teach us how to live well – not just how to live long – but how to live well.

"They're just enjoying life, and that's what we try to do at Council on Aging – provide opportunities for people to enjoy their life, every day that they have a life."

Run, hide, fight.

Those were the three steps that representatives from the St. Johns County Sheriff's Office recommended people take if ever confronted with an active-shooter situation.

The tips were part of a community seminar the sheriff's office presented May 23 at Valley Ridge Academy in Nocatee. The first in a series of such seminars to be held across the county, the seminar was presented by Deputy Mark M. Smith and Sgt. Brian Canova, who offered local residents specific strategies for responding to a shooter situation and focused on three main areas: education, physical and mental preparation, and survivability.

"What this does," Smith said, "it gives you

a fighting chance; it gives you information so that you can use that to increase your safety and survivability.'

Strategies presented at the seminar included:

#### Run

Have an escape route in mind; be observant upon entry. When fleeing from an incident, keep your hands up and your fingers spread so that law enforcement officers can clearly see that you are not a threat. The scene will be chaotic and multiple law enforcement agencies will be responding to the call. Help others escape if possible. Do not attempt to move wounded people, or if you decide to do so, know that you are taking a calculated risk and your chances for becoming a target are greatly increased. Leave your belongings

behind when fleeing.

#### Hide

If evacuation is not possible, find a place to hide that is out of the shooter's view and where danger is less likely to find you. Seek out rooms with lockable

offices, and storerooms. Blockade the door and silence cell phones. Dial 911 if the situation allows, remain calm and try to give as many details as you can. Be prepared to answer questions from the dispatcher. Answer law enforcement if they call out to

The presenters noted that it is reasonable to ask for proof from the person asking you to open the door to ensure they are in fact a law enforcement officer. In addition, take into account how much time has passed: The average time it takes law enforcement to arrive on scene is three minutes.

#### Fight

Fight only as a last resort and only when vour life is in imminent danger. Attempt to incapacitate the shooter and act with physical aggression. Throw items at the shooter or search for items that could be used as a

Sheriff David B. Shoar hopes the seminars will create a dialogue and get people thinking about what they would do if they were ever caught up in an active shooter incident

"A lot of times," Shoar said, "simple decisions we make when we enter a place can mean the difference between whether we survive or whether we don't survive."

#### **Seminar Takeaways**

- · The average shooting incident lasts 12 minutes. The average response time for law enforcement to arrive on scene is three minutes.
- Exercise your thoughts. Imagine "what if" scenarios and discuss with family and friends.
- · People have a tendency to become desensitized in work or home environments or in large crowds. Always be alert, aware and understating of your always evolving circumstances, and learn to trust your instincts.
- 40 percent of active shooting incidents happen in businesses.
- The most common weapon active shooters use is a pistol.
- When calling 911, provide the location of active shooter, number of active shooters, physical description, type and number of weapons and number of potential victims. Be calm and be as specific as pos-



First established in 1986, Dancin' in the Street is now a spring festival staple at the beaches. Its 30th year saw an artist lineup of 16 artists and food and merchandise booths lining several streets. As the Beaches Town Center Agency's biggest fundraiser of the year, money generated from the event goes to the ongoing beautification projects aiming to improve the central business district of Atlantic and Neptune Beach.

For those who return religiously, the added benefit of helping the community only sweetens the deal.

"I've been coming every year since 2010," said Roderiguez. "And if I can do my part to help Atlantic Beach by just having fun then I'm totally up for it."


and the beach. The shuttles will run every 20 minutes, with the final shuttles departing at 4 p.m.

## First Coast/Beaches residential real estate report

How's the market? Well, that is a complex question mainly because our market is so varied. You can have statistics on average sale price that are accurate but also a bit misleading, as one very high-end sale can skew the curve. Then you have the pseudo-experts rendering opinions based on data that may not be applicable to your exact area. Bottom line, when deciding to buy or sell, the best way to find the accurate value of a property is with a specific comparative market analysis, which examines properties in close geographic proximity as well as similar style and size.

The other key to knowing when to buy or sell is not reacting to misinformation. There have been many articles, blogs and news stories that could make you question your intentions to buy or sell property. I've seen many pieces stating that home sales are negatively impacted during election years, yet the "data" that supports that assertion shows only a tiny fluctuation.

A paper published in the British Journal of Political Science used data to look at housing sales. They found that in election years, homes sales declined between two-tenths and three-tenths of a percent? Hmmm. That

does not seem significant enough to generate this much negative press.

With all of that being clarified, let's dive into what the stats do say for the Beaches. We are comparing April 2015 to April 2016. Remember, take these with a proverbial grain of salt, as they are for general areas and as we all know beach property can change from one block to the next.

South Ponte Vedra Beach saw days on market decrease from 161 to 141 and the average sale price increase from \$516,775 to \$584,876 with the average list price increasing by about \$50,000

In the North Ponte Vedra region, days on market increased slightly from 109 to 115 but average sale price took a huge jump from \$508,238 to \$933,103 and average list price was up by roughly \$400,000.

Jacksonville Beach has taken a slight hit in days on market and average sale price, with 112 days on market compared to 97 and a sales price of \$374,460, down from \$382,277. Average list price, however, increased from \$507,246 to \$625,340.

On the other hand, Neptune Beach jumped from an average list price of \$547,945 to \$666,578 with an average sale price of \$407,600 over \$305,337. Days on market also dropped from 92 to 77.

Then we have Atlantic Beach, where things

went up across the board. Average list price soared from \$591,375 to \$773,197, with average sale price rising from \$265,993 to \$479,449. Days on market dropped from 119 to 83.

So, what does this all mean? Is it the right time to sell? Is it the right time to buy? Yes and yes... IF...it works for you. That's really the nuts and bolts of it.

There are many markets where across-the-board stats can apply, but Jacksonville is not one of those and most especially the Beaches are not in that category, either. You have to get specific information on a specific property to make a good decision about buying or selling. Don't trust online estimates, don't rely on news stories or the price for which a friend bought or sold their home. 



# Freelance assignments for Recorder laid foundation for career

When I began submitting freelance stories to my hometown newspaper, I never thought it would eventually lead me to the world's biggest sporting event

I was a rising junior at Nease High School, without a driver's license, when I first wrote about the school's sports and athletes for the Recorder. Now, more than 13 years later, I'm preparing to cover my fourth Olympic Games as a journalist and my second for NBC Olympics.

NBC Olympics earned multiple sports Emmy Awards for its coverage of the Sochi 2014 Winter Olympics, and I was blessed to be a part of that effort. But the foundations of my career – a career that I still consider very young – were set in Ponte Vedra.

I learned the tenets of journalism in John Blackford's outdoor pod classroom at Nease.

I learned on-the-job sports reporting lessons from the late Recorder Editor Grace Hayes and sports writer and photographer Jerry Norton.

Those early joys of visiting a local business, a restaurant or medical office, or even at school, and seeing my name in that newsprint will never be matched. Not at a worldwide entity such as NBC. Not at a worldwide event such as the Olympics.

My freelance work and that for Nease's student newspaper – the Vertical – proved key once I enrolled at the University of Florida in 2004. I already had a résumé and examples of my work to submit to the Gainesville Sun, which I worked for as a correspondent my first semester, and, later, the university's student paper – the Alligator.

No other incoming students at UF, one of the largest and most competitive universities in the nation, had those credentials.

I was blessed in high school to cross paths with a quarterback, who later also followed me to Florida. You may have heard of him. My professional relationship with Tim Tebow and his family, another happenstance born out of Ponte Vedra, accelerated my work in journalism while in college. No other media covering the University of Florida football team had the far-reaching knowledge of the most influential college football player of our time.

But something less optimal happened after I graduated Florida and completed two post-college internships.

I needed a job.

I was out of work and headed home to live with my parents in Ponte Vedra. This was August 2009.

Then, again, this community gave me a boost. I began writing for the Recorder again as a freelancer for the first time in several years. I was also fortunate to learn a new skill set working digitally for PGATour.com in Sawgrass. That allowed me to save for my ultimate ambition of covering an Olympics. I had secured a credential for the Vancouver

Winter Olympics as a freelancer in February 2010.


After I returned from Canada, I went back to work in Ponte Vedra. Two months later, I earned a position with Sports Illustrated in Atlanta, leaving home permanently for the first time.

After one Olympics with SI – the London 2012 Summer Olympics – I made another move to New York and then to work for NBC Sports as their lead Olympics writer.

My parents still live in Odom's Mill, my older sister off A1A and my younger brothers and sister in other Florida cities. So I visit home often, and every time I am reminded how what happened in high school 13 years ago, when my mom had to drive me to freelance assignments, laid the foundations for my career.

And how I never would have made it without this community.







# Memorial Day memories serve up succulent recipes

Being a professional chef, the question I'm most often asked is, "So, what's your specialty?"

I always answer by telling people that it is way too difficult a question to ask. It's akin to asking a music lover, "What's your favorite song?" The possibilities are infinite. Most chefs I know can't tell you what they made for specials in the past two months. We work and live in the moment. So much of what we are doing is cutting-edge flavors and techniques, produce at the peak of freshness, seasonal availability and fast-paced work environments. Life moves fast in the hectic pace of a food establishment. It's easy to get lost in the shuffle, and forget about dishes you once often made.

But oddly enough, most chefs can recall with great detail the dishes and foods that made up their path to becoming professionals – usually family favorites that stay with you for a lifetime. I call them "Bites of Passage."

I'm a sucker for nostalgia, and for my money, nothing does the trick quite like food that makes a lasting impression on you.

May 29, 1985 – Memorial Day – I was introduced to the art of dry rubbed and smoked pork shoulder by my father. He had been tooling around with this recipe for a couple years at this point and had it down pat. The blue-grey smoke from oak wood, the undeniable smell of the rub, the black bark that holds together a hunk of porcine nirvana – I have never been the same since.

Every pulled-pork sandwich that followed that day gets compared to that one. I can't have BBQ without thinking about my Dad. Even if I run across pedestrian pulled pork, I ponder what he would say –"needs more cayenne in the rub" or "used too much apple wood." I think that's what is so great about food nostalgia. For me, it's all about the lasting memories that are made with food, family, and friends. Here are some recipes for a Memorial Day feast that hopefully can make some lasting impressions on your brood.



#### **PULLED-PORK SANDWICHES**

- 4 tablespoons paprika
- 2 tablespoons kosher salt
- 2 tablespoons ground cumin
- 2 tablespoons dry mustard
- 1 tablespoon cayenne pepper
- 4 tablespoons brown sugar
- 2 tablespoons cracked black pepper
- 2 tablespoons chili powder
- 2 tablespoons ground coriander
- 1 pork butt, 5 to 6 pounds

CAROLINA BBQ SAUCE

 $\frac{1}{2}$  cup white vinegar

½ cup cider vinegar ½ tablespoon sugar

1/2 tablespoon crushed red pepper flakes

1/2 tablespoon Tabasco sauce

Salt and freshly cracked black pepper to taste

Just mix it up and reserve. (I like to put mine in a little squirt bottle or salad dressing cruet.) Serve it with the following: coleslaw, grill-roasted corn brushed with maple syrup and watermelon dressed with lime zest and honey.



You can either start this recipe the night before for lunch if you have a cabinet smoker or a fuel feeder, or early in the a.m. for dinner. On a grill with a cover,

build a small fire to one side, with hardwood charcoal for indirect cooking. Mix dry ingredients together in bowl. Apply this rub to pork butt with your hands, covering meat entirely. When flames begin to die down, leaving flickering coals, place meat on grill on the side without fire. Do not let flames touch meat at any time. Cover grill, vent slightly and cook, checking fire every 30 minutes or so, and adding a bit more fuel as necessary, for about 8 to 10 hours (your patience will be rewarded) until meat is soft to the touch. Remove meat from grill with tongs, let rest 10 minutes and pull meat apart with tongs. Serve on cheap hamburger buns (important), drizzled with sauce and a little pillow of coleslaw.

### Nocatee resident to appear on 'Wheel of Fortune'

Melissa Naldzin has loved "Wheel of Fortune" ever since she was 4 years old and played the computer version of the game on her father's Apple II GS computer.

So when the Nocatee resident, Realtor and professional photographer learned the "Wheelmobile" was coming to Jacksonville, she knew she had to audition.

That first local visit would lead to Naldzin appearing on the long-running game show: First Coast residents will have a chance to see how she fared at 7 p.m. Friday May 27, when Naldzin's episode airs locally on WTLV NBC 12.

"It truly was a once-in-a-lifetime experience," Naldzin said.

#### Taking a spin

At first, it appeared that Naldzin wouldn't win the chance to spin the wheel or buy a vowel, when her Jacksonville audition in November 2015 never happened.

"I submitted my application and sat there all day and never got called," she said. "I was so bummed."

Two months later, however, Naldzin received an email saying she had been selected for a second Jacksonville audition

"I was shocked since I wasn't picked in the first round," she said.

Naldzin went back for another local audition, where this time she advanced to calling out letters, playing a few practice games and taking a written test.

"They don't judge you on how quickly you can solve a puzzle, but rather on how well you enunciate and project your voice," she said. "They also look for high energy, lots of clapping and cheery faces."

The audition concluded with applicants being told they would be notified within two weeks if they had been selected to appear on the show. On day 15, Naldzin opened her mailbox and saw and envelope from "Wheel of Fortune." A week later, she received an email telling her to book a flight and be in California in 10 days for her taping.

"They sent a package with all the important details, so at that point it really started to sink in!" Naldzin said.

Accompanied by her mother, Naldzin spent a few days exploring the Los Angeles area before tackling the big wheel in the television studio.

"The set is actually smaller in person," she said. "We filmed five shows that day, so when it wasn't our game, we were able to watch the other contestants and cheer them on. The contestant coordinators were fantastic and so helpful and encouraging – they felt like family by the end of the day."

But solving the puzzles in the studio was a lot different than playing along at home, Naldzin found. "It's one thing to know the puzzle before anyone else," she said, "but having to wait your turn to solve it or trying to avoid Bankrupt or Lose a Turn can be a little intimidating – plus the wheel weighs about 2,400 pounds!"

Now that she is back in Nocatee and waiting to see her episode on TV, Naldzin described her "Wheel of Fortune" experience as both "surreal" and "absolutely incredible."

"I remember thinking to myself, 'Wow, I really am standing next to Pat Sajak and I really am on Wheel of Fortune right now!" she said. "Living in that exact moment was just spectacular and one that I am so grateful for – I smile every time I think about it!"

Episcopal School of Jacksonville senior Alice Choi was honored at the Mayo Clinic on May 17 for her research on the early detection of kidney cancer.





Steve McCormick took the podium with a proud smile as the applause for the processional quieted. "The greatest compliment I think I can pay him," Lyons began, "is to tell him that when I look at him, I don't see a quarterback. But I see someone who I would trust as my doctor ... I would trust him with my health, and with my life."

Ahuja was met with thunderous applause for his speech, a heartfelt message of gratitude and a personal story about his late sister, who died after battling a mitochondrial disease. Having never shared his story with his classmates before his speech, Ahuja said he hoped it might inspire them.

"Her courage today serves as the guiding principle of my life," he said. "And so I share with you what she taught me: never give up, no matter the odds. Trust me, you'll find great strength in the end."

Valedictorian Yooree Ha wrapped up the opening with a rousing speech in which she tearfully thanked her parents for their sacrifices in emigrating from South Korea, congratulated her classmates and reminded them to be grateful for their opportunities.

"Don't take your opportunities for granted," she said. "Celebrate and be proud, but also be aware that you've been blessed. Take this blessing and do good with it."







## Municipal bonds: Safe or risky?

In the midst of current stock market volatility and continuing low yields on investment grade corporate bonds, the returns on municipal bonds, while not outstanding, have caused sales of these securities to hold steady.

Municipal bonds may not be exciting, but most have delivered a predictable return for some time, which makes them attractive compared to the unpredictability of the stock and corporate bond markets. Interest paid on municipal bonds is free from federal income tax and may be tax free from state income depending on individual state rules.

In my opinion, there are several reasons why the trend favoring municipals may be overblown:

- 1) As stated above, the tax-free nature of municipal bond interest is something that only pencils out of a 35 percent+ tax bracket taxpayer; if you are not in that bracket, then you may do better to buy taxable bonds and pay the tax.
- 2) As our country's demographics shift

from more people working and few retired or not working to one in which more people are retired or not working than those who work – a state that we are closing in on rapidly – government at all levels is going to encounter greater difficulty in generating the tax or other revenues needed to pay their expenses, including bond principal and interest. Just look at the ration of credit downgrades versus upgrades by rating agencies such as Moody's or Standard & Poor's to get a sense of the direction of municipal finances.

3) While it is widely known that state and local governments have varying degrees of unfunded pension liabilities, the true magnitude of this crisis has yet to be reflected in most municipal financial statements. I saw a recent study that estimated that unfunded obligation at \$3.4 trillion and climbing. Needless to say, if state and local governments have to raise billions to meet their pension funding requirements, their ability to provide services to citizens and pay their debt obligations may suffer.

These trends will not cause municipal bond issuers to all crash and burn at the same time; these are circumstances that will erode their debt capacity over a period of time. It has already begun, however, as we witnessed in Detroit, Birmingham and Harrisburg just to name a few. If you are thinking about adding municipal bonds to your portfolio, consider how to do so in a way that mitigates some of the risk. Owning a stilled of a pool of bonds can reduce the impact of a default, and owning bonds which all mature in a couple of years can mitigate interest-rate risk. Knowing and understanding your options is key.




